Docket No. 48268, *Application of Simply Aquatics Inc. for a Price Index Rate Adjustment (Vista Verde)*

The proposal for decision that is before the Commission recommends that this proceeding be dismissed without prejudice on two, separate grounds: failure to prosecute and failure to amend an application such that it is sufficient *after repeated determinations* that the application is insufficient.¹

While I agree with the administrative law judge's recommendation that dismissal without prejudice is appropriate because the applicant has failed to prosecute its application, I do not believe that the facts in this proceeding support dismissal for failure to amend after repeated determinations that the application was insufficient. That is because I can only locate one determination of insufficiency by the ALJ in this proceeding.² (Commission Staff made more than one recommendation that the application be found insufficient, but those recommendations are not determinations.) Therefore, I recommend that the Commission adopt in part and reject in part the proposal for decision, dismissing this proceeding without prejudice solely on the basis of failure to prosecute.

I also propose delegating to the Office of Policy and Docket Management staff the authority to modify the Commission's order to conform to the *Citation and Style Guide for the Public Utility Commission of Texas* and to make other non-substantive changes to the order for such matters as capitalization, spelling, grammar, punctuation, style, correction of numbering, and readability.

I look forward to discussing this matter with you at the open meeting.
