**NUECES WATER SUPPLY CORPORATION'S  
REQUEST FOR EXTENSION**

Applicant Nueces Water Supply Corporation ("Nueces WSC") files this Request for Extension. In support thereof, Applicant shows the following:

**I. BACKGROUND**

On April 18, 2018, Cyndie Park 2 and Nueces WSC filed an application for sale, transfer, or merger of facilities and certificate rights in Nueces County, Texas. Specifically, Cyndie Park 2 seeks to transfer its water service area and facilities under Certificate of Convenience and Necessity No. 12100 to Nueces WSC. The service area to be transferred includes 30.2 acres and 18 customers.

On May 29, 2019, the Administrative Law Judge ("ALJ") issued Order No. 10 setting a procedural schedule that includes a July 22, 2019 deadline for parties to jointly file detailed, legally sufficient findings of fact and conclusions of law that meet the components of TWC §13.246 and that supports the relief requested.

**II. REQUEST FOR EXTENSION**

Nueces WSC requires additional time to prepare the required documents. Nueces WSC requests that the current deadline of July 22, 2019 reference above be extended for good cause until August 5, 2019. All parties have been contacted and are unopposed to the extension.
