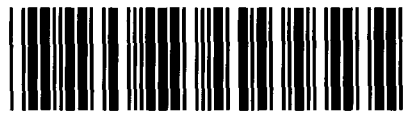

COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Recommendation on Sufficiency of Notice.

I. BACKGROUND

On April 19, 2018, Levi Water Supply Corporation (Levi WSC) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 10018 in McLennan and Falls Counties, Texas. Order No. 2 required that Staff file a recommendation on sufficiency of notice within 10 days of receiving proof of notice. Levi WSC filed its proof of notice affidavits on September 4, 2018, making Staff's recommendation due on or before September 14, 2018. Therefore, this pleading is timely filed.

II. STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

On September 4, 2018, Levi WSC filed its proof of notice with the Commission. Staff has reviewed the proof of notice. Staff recommends that the notice provided be found sufficient.

III. PROPOSED PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:

Notice completed	August 20, 2018
Deadline for intervention	September 19, 2018 ¹

¹ Pursuant to 16 TAC § 24.106(a)(3), the intervention deadline is 30 days after the mailing or publication of notice, whichever occurs later. Notice was mailed on August 20, 2018 and published on August 8, 2018; August 10, 2018; August 15, 2018; and August 17, 2018 in appropriate newspapers of general circulation in each county for two

Deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to the Applicant for review and consent	October 19, 2018
Deadline for Applicant to file signed consent forms with the Commission	November 2, 2018
If no hearing is requested, deadline for Staff to file a recommendation on final disposition	November 9, 2018
If no hearing is requested, deadline for the Applicant to file a response to Staff's recommendation on final disposition. If no response is filed, the parties shall file a joint proposed notice of approval.	November 16, 2018

IV. CONCLUSION

For the reasons discussed above, Staff recommends that Levi WSC's proof of notice be found sufficient and that the proposed procedural schedule be adopted.
