COMMISSION STAFF'S AMENDED FINAL RECOMMENDATION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files Amended Final Recommendation. In support thereof, Staff shows the following:

I. BACKGROUND

On April 19, 2018, Levi Water Supply Corporation (Levi WSC) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 10018 in McLennan and Falls Counties, Texas. Order No. 4 required that Staff file a recommendation on final disposition by November 9, 2018. On November 8, 2018, Staff filed a Final Recommendation in which the conclusion section of that pleading inadvertently requested that the ALJ enter an order permitting the proposed transaction to proceed. However, this proceeding does not involved a proposed transaction and Staff intended instead to request that the application be approved; Staff apologizes for any inconvenience caused by the inadvertent request.

II. STAFF'S AMENDED FINAL RECOMMENDATION

Because no transaction is at issue in this proceeding, Staff requests that the ALJ simply approve the application. The Staff expert's memorandum recommending approval of the application and the certificate and map related to this proceeding were filed along with Staff's Final Recommendation on November 8, 2018. On or before November 16, 2018, the parties will jointly file proposed findings of fact and conclusions of law.

III. CONCLUSION

Staff respectfully recommends the entry of an order approving the application.


