

Dear Quadvest customer:

Quadvest, LP is pleased to notify you that it has voluntarily taken proactive measures and sought approval from the Public Utility Commission of Texas (PUC) to implement a Federal Tax Change Credit Rider (FTCCR) effective for bills issued after May 1, 2018. The FTCCR will immediately lower your monthly bills and be represented as a new line item on each bill until further notice.

Quadvest has developed the FTCCR as a way to immediately pass estimated tax savings resulting from the federal Tax Cuts and Jobs Act of 2017 (TCJA) to customers as quick as possible without a rate case. While the FTCCR remains subject to final regulatory authority approval, Quadvest's proposal includes implementation of the FTCCR as an interim rate immediately to benefit our customers without delay.

The FTCCR that will be applied to your bills after May 1, 2018 through December 31, 2018 is \$0.53 for water and \$6.82 for sewer (if applicable). Then, effective for bills issued after January 1, 2019, the FTCCR will drop somewhat to \$0.37 for water and \$4.37 for sewer (if applicable). The credit on your bill in 2018 is slightly higher because the TCJA was effective January 25th, 2018, however the credit will not be reflected on your bill until May. Therefore, the tax savings for 2018 is spread out over 8 months, where the tax savings for 2019 will be spread out over a full 12-month period. The 2019 FTCCR will remain in place until the point when Quadvest files its next rate case.
