### COMMISSION STAFF'S ADMINISTRATIVE COMPLETENESS RECOMMENDATION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this response to Order No. 1, Staff's Administrative Completeness Recommendation. Staff recommends that the application be deemed administratively complete and that the applicant be ordered to issue notice. In support thereof, Staff shows the following:

#### I. BACKGROUND

On May 1, 2018, El Paso Water Utilities Public Service Board (EPWU) filed an application to decertify a portion of both its water certificate of convenience and necessity (CCN) No. 10211 and sewer CCN No. 21008 in El Paso County. EPWU seeks to relinquish approximately 487 acres from its sewer CCN and 342 acres from its water CCN. EPWU is not currently providing water or sewer service within the subject areas.<sup>1</sup>

On May 2, 2018, the Commission Administrative Law Judge (ALJ) issued Order No. 1, requiring Staff to file a recommendation on the administrative completeness of EPWU's application and proposed notice by May 31, 2018. Therefore, this pleading is timely filed.

#### II. APPLICATION SUFFICIENCY RECOMMENDATION

As detailed in the attached memorandum of Sherrie Keylon of the Commission's Water Utility Regulation Division (Attachment A), Staff has reviewed EPWU's application and determined that it is sufficient. Therefore, Staff recommends that the application be deemed administratively complete and accepted for filing.

#### III. PROPOSED NOTICE

Staff has included as Attachments B and C notice for EPWU to provide that meets the requirements of 16 Texas Administrative Code (TAC) § 24.106. Pursuant to 16 TAC § 24.106(a)(2), EPWU should include a map with the each notice showing the proposed service area to be relinquished.

Staff recommends that EPWU be directed to provide the attached approved notice to any cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles of the outer boundary of the requested area to be relinquished. As required by 16 TAC § 24.106(b), Staff also recommends that EPWU provide notice to the county judge of each county wholly or partially included within the proposed area to be relinquished, each groundwater conservation district wholly or partially included within the proposed area, each city with an extraterritorial jurisdiction (ETJ) wholly or partially included in the proposed area, any affected customers, and any potential water or sewer utility customers located wholly or partially within the proposed area.<sup>2</sup> The attached memorandum includes a non-exhaustive list of entities to whom EPWU should issue notice. Additionally, Staff recommends that EPWU publish the approved notice once each week for two consecutive weeks in a newspaper of general circulation in El Paso County, as required by 16 TAC § 24.106(c).

After EPWU has completed issuance of such notice and in accordance with 16 TAC §§ 24.106(b)(4) and (c), Staff recommends that EPWU file within 30 days of the latest date of notice a copy of the actual notice sent, including attachments. EPWU should include with its notice filing the attached affidavits (Attachments D and E), completed and signed, affirming that such notice was issued and listing each entity and person to whom notice was issued.

<sup>&</sup>lt;sup>2</sup> Pursuant to 16 Texas Administrative Code § 24.106(b)(2) (TAC), an applicant is also required to, "mail notice to each owner of a tract of land that is at least 25 acres and is wholly or partially included in the requested area." The purpose of this notice section is to ensure that landowners above a certain threshold have the opportunity to opt-out of a service area being expanded. See Texas Water Code §§ 13.254(a-1) and (a-5); see also 16 TAC §§ 24.113(k) and (l). However, because no additional service area is being requested by the applicant in this proceeding, the purpose of such notice requirement does not apply. Therefore, Staff recommends a good cause exception be granted to the requirement of 16 TAC § 24.106(b)(2).

#### IV. PROPOSED PROCEDURAL SCHEDULE

Staff recommends that the application be found administratively complete. In accordance with that recommendation, Staff proposes the following procedural schedule:

Deadline for Staff to file a recommendation regarding the sufficiency of EPWU's notice	July 27, 2018	
Deadline to intervene	30 days after notice is issued	

Staff intends to file an additional proposed procedural schedule with its recommendation on the sufficiency of notice that includes subsequent proposed deadlines.

#### V. CONCLUSION

For the reasons stated above, Staff respectfully recommends that the application be found administratively complete, that EPWU be ordered to provide notice using the attached templates, and that the above proposed procedural schedule be adopted.

On May 1, 2018, El Paso Water Utilities Public Service Board filed (El Paso Water Utilities PSB or Applicant) with the Public Utility Commission of Texas (Commission) an application to amend its water Certificate of Convenience and Necessity (CCN) No. 10211 and sewer CCN No. 21008 to relinquish portions of its service area in El Paso County, Texas. Applicant seeks to relinquish approximately 487 acres from sewer CCN No. 21008 and approximately 342 acres from water CCN No. 10211. This application was filed pursuant to Texas Water Code (TWC) §§ 13.241 to 13.250 and the 16 Texas Administrative Code (TAC) §§ 24.101 to 24.107.

Based on Staff's review of the above referenced application, Staff recommends that the application be deemed sufficient for filing and be found administratively complete. Staff also recommends the following:

- 1) Provide notice of the application to the following:
  - a) cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area to be relinquished;
  - b) the county judge of each county that is wholly or partially included in the requested area to be relinquished;
  - c) each groundwater conservation district that is wholly or partially included in the requested area to be relinquished;
  - d) affected customers;
  - e) every potential water or sewer utility customer within the requested area to be relinquished; and
  - f) publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in El Paso County.

- 3) Provide an accurate map delineating the requested service area relinquishment with each individual notice to neighboring utilities and other affected parties. Information related to districts, including addresses, can be obtained by the Applicant from the Texas Commission on Environmental Quality (TCEQ) web site located at <a href="http://www14.tceq.texas.gov/iwud/">http://www14.tceq.texas.gov/iwud/</a>.
- 4) Within 30 days of the date of the notice, file in this docket a map and copy of notice along with an affidavit specifying every person and entity to whom notice was provided, the date that the notice was provided, and including the publisher's affidavit for proof of newspaper publication. It is recommended that the Applicant use the attached notices and affidavits to meet these requirements.


