COMMISSION STAFF'S REQUEST FOR AN EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for an Extension. In support thereof, Staff shows the following:

I. BACKGROUND

On May 25, 2018, Monarch Utilities I, L.P. (Monarch) filed with the Commission an application for approval to implement a new federal tax change credit rider which will be used to provide a credit to Monarch customers. Notice Addressing Sufficiency, Adopting Procedural Schedule, and Approving Credit Rider on an Interim Basis, issued on June 27, 2018, deemed the application sufficient for further review, established a procedural schedule, and approved the proposed federal tax change ride on an interim basis.

II. REQUEST FOR AN EXTENSION

Staff is working with Monarch to verify the proper calculation of the Federal Tax Change Credit Rider. Staff is requesting an extension to file its recommendation in this docket, as well as an extension for the deadline to file a joint proposed notice of approval if no hearing is requested. Therefore, Staff is respectfully requests the following modifications to the procedural schedule:

Event	Date
Deadline for Staff to file a final recommendation or request a hearing	July 20, 2018 August 1, 2018
If no hearing requested, deadline to file a joint proposed notice of approval	July 27, 2018 August 8, 2018

Staff is authorized to represent that Monarch is unopposed to Staff's request.

III. CONCLUSION

Staff respectfully requests the entry of an order adopting the above proposed modifications to the procedural schedule.
