# COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY AND PROPOSED PROCEDURAL SCHEDULE

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Recommendation on Sufficiency and Proposed Procedural Schedule. In support thereof, Staff shows the following:

# I. BACKGROUND

On May 25, 2018, Monarch Utilities I, L.P., (Monarch) filed with the Commission an application for approval to implement a new Federal Tax Change Credit Rider which will be used to provide a credit to Monarch customers effective for bills rendered on or after July 1, 2018.

Notice Setting Deadline for Staff's Recommendation, issued on May 29, 2018, instructed Staff to file a recommendation or propose a procedural schedule by June 25, 2018. Therefore, this pleading is timely filed.

### II. SUFFICIENCY

Staff has reviewed Monarch's application and has determined it contains no material deficiencies. Staff recommends that Monarch's application be deemed sufficient for further review. Staff is continuing its review to make a recommendation on final disposition.

#### III. PROPOSED PROCEDURAL SCHEDULE

Staff recommends approval of the following proposed procedural schedule:

Deadline to intervene	June 25, 2018
Deadline for Staff to file a final recommendation or request a hearing	July 20, 2018
If no hearing requested, deadline to file a joint proposed notice of approval	July 27, 2018

Staff respectfully requests the application be deemed sufficient for further review and that the proposed procedural schedule be adopted.
