**MOTION TO INTERVENE OF ATMOS PIPELINE – TEXAS**

COMES NOW Atmos Pipeline – Texas (“APT”), a division of Atmos Energy Corporation, and submits this Motion to Intervene in the captioned proceeding pursuant to the Public Utility Regulatory Act and Public Utility Commission of Texas Procedural Rules 22.103 and 22.104. In support of its motion, APT would show the following:

**I. INTRODUCTION**

On May 31, 2018, LCRA Transmission Services Corporation filed an application in this proceeding to amend its certificate of necessity and convenience in order to authorize construction of the proposed Cooks Point 138-kV transmission line in Burleson County. APT owns natural gas transmission facilities that may be impacted by the proposed transmission routes. Thus, APT is directly affected by the proposed line, has a justiciable interest in this proceeding, and has standing to intervene.



WHEREFORE, PREMISES CONSIDERED, APT respectfully requests to be permitted to intervene in this matter and to be granted party status in this docket.


