MOTION TO WITHDRAW APPLICATION

Nueces Water Supply Corporation ("Nueces WSC") files this Motion to Withdraw Application filed in this Docket and in support thereof would respectfully show as follows:

Nueces WSC filed an Application for Sale, Transfer, or Merger with the Public Utility Commission of Texas ("PUC") on May 15, 2018 to request all certificate rights of Cyndie Park Unit I Water Coop ("CPI"). The PUC Staff's Recommendation on Administrative Completeness filed on June 13, 2018 noted that an application for a sale, transfer, or merger requires a signed contract, bill of sale or other agreement between the two utilities, and Nueces WSC does not have any agreement with CPI due to the fact that no representative of CPI can be located. The Administrative Law Judge's Order No. 2 filed on June 15, 2018 subsequently deemed Nueces WSC's application incomplete and deficient pursuant to the PUC Staff's recommendation.

Counsel for Nueces WSC has conferred with PUC Attorney Heath Armstrong who has no objection to this Motion.

Therefore, Nueces WSC respectfully requests that the Administrative Law Judge grant this Motion to Withdraw Application in order to allow Nueces WSC to file the proper application to request the certificate rights of CPI.
