



Pursuant to Public Utility Commission of Texas ("PUC") Order No. 1 in Docket No. 48375, Application of City of Elgin and Aqua Water Supply Corporation for Approval of Service Area Contract Under Texas Water Code § 13.248 and to Amend Certificates of Convenience and Necessity in Bastrop County. Aqua Water Supply Corporation ("Aqua WSC") would like to provide the following requested information:

- 1. The legal name under which Aqua WSC conducts business is Aqua Water Supply Corporation. Aqua WSC does not use any assumed names.
- 2. Aqua WSC is a domestic nonprofit water supply corporation. Aqua WSC's Charter No. is 25894701. Aqua WSC was created by Articles of Incorporation on June 6, 1968. Aqua WSC's Articles of Incorporation were amended once on March 6, 1995.
- 3. Aqua WSC does not have a parent company or any affiliated company.

ARTICLE I.

ARTICLE II.

The Corporation is a non-profit Corporation organized under Article 1434a of the Revised Civil Statutes of Texas of 1925, as amended, supplemented by the Texas Non-Profit Corporation Act, Article 1.01 et seq., as amended, and is authorized to exercise all powers, privileges and rights conferred on a - Corporation by these Acts, and all powers and rights incidental in carrying out the purposes for which the Corporation is formed, except such as are inconsistent with the express provisions of these Acts.

ARTICLE III.

The period of its duration is perpetual.

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF AOUA WATER SUPPLY CORPORATION

Pursuant to the provisions of Article 1396-4 03 of the Texas Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation

ARTICLE ONE

The name of the corporation is Aqua Water Supply Corporation

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the corporation on March 3, 1995. Article IV of the Articles of Incorporation is hereby amended to read as follows:

"The corporation is formed for the purpose of furnishing a water supply, sewer service, or both upon request for general farm use and domestic purposes, and to any legal entity including towns, cities, private corporations, individuals, and military camps and bases, in Bastrop County, Texas, and the surrounding counties of Caldwell, Fayette, Lee, Travis and Williamson. The places where the business of the corporation is to be transacted shall be the Bastrop County of Bastrop County, Texas, and the surrounding rural areas."

ARTICLE THREE

The amendment was adopted in the following manner:

The amendment was adopted at a meeting of members held on March 3, 1995, at which a quorum was present. The amendment received at least two-thirds of the votes that members who were present or represented by proxy at the meeting were entitled to cast.
