UNDINE TEXAS, LLC'S RESPONSE TO ORDER NO. 1

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

Undine Texas, LLC ("Undine") files this response to Order No. 1. In support thereof, Undine states the following:

I. BACKGROUND

On May 24, 2018, Undine filed with the Public Utility Commission of Texas ("Commission") an application for sale, transfer, or merger of a retail public utility in Johnson and Tarrant Counties. On May 30, 2018, the Administrative Law Judge ("ALJ") filed Order No. 1 requiring Commission Staff's Recommendation and directing Undine to provide information and supporting documentation on or before June 4, 2018. Accordingly, this response is timely filed.

II. SUPPLEMENTAL INFORMATION

In response to Order No. 1, Undine hereby files the following information:

1. The legal name and all assumed names, if any, under which the applicant conducts business. If the applicant uses an assumed name, provide a currently valid certificate of assumed name.

Response:

Undine conducts business under the name of Undine Texas, LLC (Employer Identification Number 37-1817184). It does not conduct business under an assumed name.

2. The form of business in Texas (e.g., corporation, partnership, sole proprietorship). Charter or Authorization number, date business was formed, and date change was made (if applicable).

Undine operates as a limited liability company. Attached as Exhibit A is Undine's Certificate of Formation dated October 23, 2015 and attached as Exhibit B is the Secretary of State Certificate of Filing for Undine dated November 25, 2015.


