**ORDER NO. 4
FINDING NOTICE SUFFICIENT AND
ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses the application of Chuck Bell Water Systems, LLC and Undine Texas, LLC for sale, transfer, or merger of facilities and certificate rights in Johnson and Tarrant Counties. On September 24, 2018, Commission Staff recommended the administrative law judge (ALJ) find the provision of notice sufficient. Applicants filed proof of notice on September 14, 2018, and fully completed notice on September 8, 2018. The 120-day deadline to approve the sale administratively or require a public hearing is January 7, 2019. Commission Staff proposed a procedural schedule based on that deadline.

The ALJ finds the notice sufficient and adopts the following procedural schedule:

Event	Date
Deadline to Intervene	October 8, 2018 ¹
Deadline for Commission Staff to request a hearing or file a recommendation on approval of the sale and on the certificate of convenience and necessity amendment	November 7, 2018
Deadline for parties to file a response to Commission Staff's recommendation	November 21, 2018
120-day deadline for the Commission to approve the sale or require a hearing	January 7, 2019 ²

¹ Under 16 TAC § 24.109(c)(3), the intervention deadline is 30 days after the mailing or publication of notice, whichever occurs later. Notice was mailed August 24, 2018 and published on September 1, 2018 and September 8, 2018. Therefore, 30 days after September 8, 2018 is October 8, 2018.

² Under 16 TAC 24.109, the deadline for Commission action is 120 days after the later of either when the application is filed, when the notice was mailed, or when notice is published. Therefore, 120 days after September 8, 2018 is January 6, 2019. As that date falls on a weekend, the next business day is January 7, 2019, under 16 TAC § 22.4(a).
