



In accordance with the aforementioned statute, Undine Texas, LLC affirmatively states that its water service area included in the aforementioned CCN is as follows:

Bell Manor Estates:

The area subject to this transaction is located approximately 6 miles west of downtown Burleson, TX, and is generally bounded on the north by a line 350' north of Sparks Lane; on the east by FM 1902; on the south by CR 920; and on the west by a line 500' east of Valley View Road. The requested area includes approximately 63 total acres and 24 current customers.

Buffalo Creek Estates:

The area subject to this transaction is located approximately 4 miles northeast of downtown Cleburne, TX, and is generally bounded on the north by a line 700' north of Steinway Lane; on the east by CR 801A; on the south by CR 801A; and on the west by East Buffalo Creek. The requested area includes approximately 130 total acres and 49 current customers.

Crowley Two Acres Addition:

The area subject to this transaction is located approximately 8 miles west of downtown Burleson, TX, and is generally bounded on the north by a line 0.5 mile north of CR 920; on the east by CR 1015; on the south by Chisholm Trail; and on the west by Anna Dale Lane and East Chisholm Court.
