Pursuant to Texas Water Code § 13.257, Aqua Texas, Inc., holder of Certificate of Convenience and Necessity No. 13201, hereby files this Boundary Description for the portion of Aqua Texas, Inc.'s CCN No. 13201 that was released by the PUC in a December 6, 2018 written order in Docket No. 48396. The portion of Aqua Texas' CCN that was released is approximately 61.8 acres of a tract owned by B&M Properties, Joint Venture in Denton County located at the intersection of John Wiley Road and FM 156 and fully described in the Warranty Deed with Vendor's Lien filed of record in Denton County as Document# 1997-14953. 
