**ORDER NO. 3
ADDRESSING SUFFICIENCY OF APPLICATION AND NOTICE;
AND ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses the application of Crest Water Company (Crest Water) to amend a certificate of convenience and necessity. On August 27, 2018, Commission Staff filed a recommendation regarding administrative completeness of the application and proposed notice of Crest Water.

Commission Staff recommended that the administrative law judge (ALJ) find the application administratively complete. Commission Staff recommends that the ALJ require Crest Water to provide notice and a map with each notice, and file signed affidavits as detailed in Commission Staff's supplemental recommendation and using the included forms. Commission Staff recommends that Crest Water should supplement the application with a copy of loan approval documents and affidavit from the owner attesting to infusion of capital for facility upgrades required under 16 TAC § 24.11(e)(5). Commission Staff proposed a procedural schedule for continued processing of this application.

The ALJ finds the application administratively complete and directs Crest Water to provide notice of the application as described in Commission Staff's supplemental recommendation using the included forms. Crest Water must supplement the application with copy of loan approval documents and an affidavit from the owner attesting to infusion of capital for facility upgrades. The proposed procedural schedule is adopted as follows:
