On June 11, 2018, Nzinga Hughes (Hughes) filed a complaint against The Trails at Dominion Park (The Trails), Ab-Go Trails at Dominion Park Propco, LLC (Ab-Go Trails), NWP Services Corporation (NWP), Harris County Municipal Utility District No. 215 (the District), and Goldoller Real Estate Investments (Goldoller).

On August 28, 2019, the Administrative Law Judge issued Order No. 1 which required the parties to file three proposed dates to schedule a prehearing conference by September 13, 2019.

Staff respectfully requests an order consistent with its pleading.




