REQUEST OF SEGURO WATER COMPANY, LLC AND SAN PEDRO CANYON WATER RESOURCES TO PLACE BLUE CEREUS, LLC UNDER TEMPORARY MANAGEMENT OR SUPERVISION AND FOR OTHER APPROPRIATE RELIEF

Seguro Water Company, LLC (Seguro) and San Pedro Canyon Water Resources (San Pedro) respectfully file this request to place Blue Cereus, LLC (Blue Cereus) under temporary management or supervision and for other appropriate relief.

I. BACKGROUND

Blue Cereus is a retail water utility providing service in the La Caleta Estates and San Pedro Village subdivisions in Val Verde County, Texas. Seguro and San Pedro provide wholesale water supply to Blue Cereus for those subdivisions under two Agreements to Sell and Purchase Water (Agreements) entered into in 2009. For several years, Seguro and San Pedro have been engaged in extended, unsuccessful discussions with Blue Cereus to address Blue Cereus' substantial and longstanding delinquency in payment for the water supply furnished by Seguro and San Pedro.

On June 1, 2018, Seguro and San Pedro gave Blue Cereus Notice of Default and Termination under each of the Agreements due to Blue Cereus' payment delinquency. The notice letter notified Blue Cereus that, absent satisfactory arrangements for payment of the delinquent amounts, the Agreements will terminate on August 30, 2018, ninety (90) days after the date of the letter. The letter advised Blue Cereus to make arrangements for an alternative water supply or to cure the defaults prior to termination of the Agreements, and notified Blue Cereus that Seguro and San Pedro intended to promptly pursue their rights and remedies under the Agreements and applicable law, including seeking intervention by this Commission. A copy of the Notice of Default and Termination letter is attached as Attachment A. Blue Cereus has not responded to the letter.

II. REQUEST TO PLACE BLUE CEREUS UNDER TEMPORARY MANAGEMENT OR SUPERVISION AND FOR OTHER APPROPRIATE RELIEF

Due to Blue Cereus' failure to pay for its wholesale water supply and the resulting impending termination of its water supply contracts, there is an imminent risk that Blue Cereus will be unable to provide continuous and adequate service to its customers in the La Caleta Estates and San Pedro Village subdivisions. Blue Cereus' longstanding failure to pay for its wholesale water supply constitutes abandonment as defined in Texas Water Code (TWC) §13.412, and Seguro and San Pedro respectfully request that the Commission: (1) authorize a temporary manager to operate Blue Cereus; and (2) ask the Attorney General to bring suit for the appointment of a receiver to collect the assets and carry on the business of Blue Cereus, pursuant to Texas Water Code (TWC) §§ 13.412 and 13.4132.

In the event the Commission chooses not to immediately authorize a temporary manager and initiate a suit for receivership, Seguro and San Pedro request that the Commission place Blue Cereus under supervision pursuant to TWC §13.4131 and, during such supervision, require that Blue Cereus abide by the following conditions and requirements:

- 1. Within 30 days, provide Commission Staff, Seguro and San Pedro a report showing Blue Cereus' receipts and disbursements by month for the previous twenty-four months, and update the report on a monthly basis for the current month;
- 2. Within 30 days, provide Commission Staff, Seguro and San Pedro copies of the annual report submitted to the Commission or the Texas Commission on Environmental Quality for each of the last ten years, as required by 16 TAC §24.73;
- 3. Deposit all funds and receipts into an account at a financial institution approved by the Commission and use those funds only for reasonable and necessary expenses of Blue Cereus, including payment for wholesale water supply as set forth below;
- 4. Make timely payment each month for current water supply invoices from Seguro and San Pedro, plus payment each month to retire a portion of the delinquent balances reflected on Attachment A:
- 5. Within 30 days, provide Commission Staff, Seguro and San Pedro copies of all Blue Cereus' bank statements for the previous twenty-four months, and continue to provide updated bank statement(s) for the current month on a monthly basis;

- 6. Within 30 days, provide Commission Staff, Seguro and San Pedro an accounting of all salaries and benefits paid, and all capital distributions from Blue Cereus to its owners, since January 1, 2009;
- 7. Blue Cereus shall not increase salaries or benefits, make capital distributions to owners, or liquidate assets without prior Commission approval;
- 8. Within 30 days, provide Commission Staff, Seguro and San Pedro a list of Blue Cereus' account receivable and payable for each of the preceding twenty-four months;
- 9. Provide Commission Staff, Seguro and San Pedro a report on a monthly basis including the account status and any delinquent payments made by Blue Cereus' customers and collection status.

III. CONCLUSION

In light of Blue Cereus' longstanding and ongoing failure to pay for its wholesale water supply, Commission intervention is necessary to ensure that Blue Cereus continues to provide continuous and adequate service to its customers. Seguro and San Pedro respectfully request that the Commission authorize a temporary manager to operate Blue Cereus and ask the Attorney General to initiate a receivership proceeding. In the alternative, Seguro and San Pedro request that the Commission place Blue Cereus under supervision with the conditions and requirements identified above.

Dear Mr. Hall,

This firm has been retained to represent Seguro Water Co., LLC ("Seguro") and San Pedro Canyon Water Resources ("San Pedro") in connection with delinquent payments owed by Blue Cereus, LLC ("Blue Cereus") for wholesale water supplied to Blue Cereus by Seguro and San Pedro under the Agreement to Sell and Purchase Water Between Seguro Water Co., LLC and Blue Cereus, LLC ("Seguro Agreement") and the Agreement to Sell and Purchase Water Between San Pedro Canyon Water Resources and Blue Cereus, LLC ("San Pedro Agreement"), respectively. As of the date of this letter, the amount past due and owing from Blue Cereus to Seguro is \$103,862.97, as shown on Attachment A, and the amount past due and owing from Blue Cereus to San Pedro is \$39,419.54, as shown on Attachment B. Blue Cereus' failure to timely pay these amounts due and owing constitutes a default and breach of each of the Agreements.

Pursuant to Section 2.02 of each of the Seguro Agreement and the San Pedro Agreement, Seguro and San Pedro hereby give notice that, absent satisfactory arrangements by Blue Cereus for payment of delinquent amounts, the Seguro Agreement and the San Pedro Agreement will terminate on August 30, 2018, ninety (90) days after the date of this letter. Blue Cereus should make arrangements for an alternative water supply or cure the defaults prior to termination of the Seguro and San Pedro Agreements.

If reasonable arrangements are not made within ten days to address Blue Cereus' past due balances, Seguro and San Pedro also intend to promptly pursue their rights and remedies under the Agreements and applicable law, including without limitation requesting that the Public Utility Commission of Texas appoint a temporary manager and seek appointment of a receiver for Blue Cereus.
