NOTICE OF APPROVAL

This Notice addresses the application of Manvel Terrace Utilities, Inc. for a price-index rate adjustment. The Commission adjusts Manvel Terrace's monthly base rate to \$33.48 and the gallonage rate to \$3.91.

The Commission adopts the following findings of fact and conclusions of law:

I. Findings of Fact

Applicant

- 1. Manvel Terrace is a for-profit corporation registered with the Texas Secretary of State under file number 0078001700.
- 2. Manvel Terrace holds certificate of convenience and necessity (CCN) number 12080, operates public water system number 0200102 and serves 77 connections.

Application

- 3. On June 13, 2018, Manvel Terrace filed an application for a price-index rate adjustment and proposed an effective date of July 31, 2018.
- 4. Manvel Terrace requested an adjustment to its monthly base rate and gallonage rate based on the Commission's current price index of 3.50%.
- 5. Manvel Terrace indicated it needs the increase to address water system well issues. The system experienced an outage over the Memorial Day weekend.
- 6. In Order No. 2 issued on July 24, 2018, the administrative law judge (ALJ) found the application administratively complete.

Rate Adjustment Requested

7. Manvel Terrace proposed increasing the monthly base rate from \$32.35 to \$33.48 and the

- gallonage rate from \$3.78 to \$3.91 per 1,000 gallons.
- 8. On July 13, 2018, Commission Staff proposed an effective date of August 31, 2018 for the rate increase and recommended that the ALJ direct Manvel Terrace to provide notice at least 30 days before the effective date of the proposed rate change.

Notice

9. In Order No. 2 issued on July 24, 2018, the ALJ directed Manvel Terrace to issue notice to customers 30 days before the effective date of August 31, 2018.

Filing Schedule

- 10. A class C utility with a CCN number ending in 80 may file an application for a price-index rate adjustment in the month of September, unless good cause is shown for filing in a different month.
- 11. The Commission last approved a rate increase for Manvel Terrace, a 1.57% price-index rate adjustment in 2016, in Docket No. 46559.¹
- 12. Prior to the rate increase in 2016, Manvel Terrace increased its rates in 2007.²
- 13. Manvel Terrace's recent issues with its water system and minimal increases to rates in recent years demonstrate good cause for filing this application outside of the scheduled month of September.

Annual Report

14. Manvel Terrace must file its annual service, financial, and normalized earnings report which is due on June 1 of each year, as required by 16 Texas Administrative Code (TAC) § 24.73.

Informal Disposition

- 15. Manyel Terrace and Commission Staff are the only parties to this proceeding.
- 16. No party requested a hearing.

17. On July 13, 2018, Commission Staff recommended approval of the application.

II. Conclusions of Law

- 1. The Commission has jurisdiction over the application under Texas Water Code (TWC) §§ 13.041 and 13.1872.
- 2. Manvel Terrace is a utility as defined in TWC § 13.002(23) and is a Class C utility under TWC § 13.002(4-c).
- 3. Under TWC § 13.1872(f), Manvel Terrace may adjust its rates not more than once each year and not more than four times between rate proceedings under TWC § 13.1871.
- 4. The Commission-approved price index for calendar year 2018 is 3.5%.³
- 5. The Commission may make exceptions to sections in chapter 24 for good cause under 16 TAC § 24.2(b).
- 6. Good cause exists to grant Manvel Terrace an exception to file outside of their scheduled month of September as required by 16 TAC § 24.36(f)(2)(I).
- 7. Under 16 TAC § 24.73, Manvel Terrace is required to file a service, financial, and normalized earnings report on June 1 of each year.
- 8. The Commission processed the application in accordance with the requirements of the Administrative Procedure Act (APA),⁴ TWC, and the Commission's rules.

III. Ordering Paragraphs

In accordance with these findings of fact and conclusions of law, the Commission issues the following orders:

1. The Commission adjusts Manvel Terrace's monthly base rate to \$33.48 and the gallonage rate to \$3.91 as reflected in the attached tariff.

- 2. Under 16 TAC § 24.2, the Commission grants a good cause exception for Manvel Terrace to be allowed to file outside of their scheduled month of September.
- 3. Manvel Terrace is required to file all future rate adjustment applications according to the schedule in 16 TAC § 24.36.
- 4. Manvel Terrace is required to timely file a service, financial, and normalized earnings report by June 1 of each year as required under 16 TAC § 24.73.
- 5. The Commission denies all other motions and any other requests for general or specific relief, if not expressly granted.
