**ORDER NO. 1  
 REQUIRING COMMENTS ON ADMINISTRATIVE COMPLETENESS AND NOTICE;  
 AND ESTABLISHING PROCEDURAL SCHEDULE**

**I. Petition**

This Order addresses the petition filed by EQK Bridgeview Plaza, LLC for expedited release of approximately 2807 acres of land within High Point Water Supply Corporation's water certificate of convenience and necessity (CCN) No. 10841 in Kaufman County.

**II. Requiring Comments on Administrative Completeness of the Petition and Notice**

By July 23, 2018, Commission Staff shall file comments on the administrative completeness of the petition and notice.

Notice of this petition will be published in the *Texas Register*. A copy of the notice filed with the *Texas Register* is being provided to High Point WSC at their address of record:

High Point WSC must file a motion to intervene by July 23, 2018 in order to participate as a party in this proceeding.<sup>1</sup>

### III. Establishing Procedural Schedule

The following procedural schedule shall apply to this proceeding:

Publication of <i>Texas Register</i> notice	July 6, 2018
Commission Staff's comments on administrative completeness and notice	July 23, 2018
Deadline for the High Point WSC and other affected persons to file a written protest or motion to intervene and file comments on the petition	July 23, 2018

Additional deadlines will be established after the petition is deemed administratively complete.

### IV. Filing Requirements

Unless otherwise specified, an original and ten copies of documents relating to this proceeding must be filed with the Commission filing clerk under 16 Texas Administrative Code (TAC) § 22.71. A copy of each document filed with the Commission must also be served on all parties as provided in 16 TAC § 22.74. All filings can be accessed on the PUC Interchange, <http://interchange.puc.texas.gov>.

All parties shall provide their current addresses, telephone number, if available, to all other parties and the Commission by filing and serving all parties with such information. Each party shall provide the Commission and all parties with updated address, telephone and information, if such information changes. The telephone number will be placed on the service list for this proceeding. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

### V. Ex Parte Communications


