COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request for Extension. In support thereof, Staff shows the following:

On June 26, 2018, MSEC Enterprises, Inc. (MSEC) filed an application to amend water certificate of convenience and necessity number (CCN) 12887 in Montgomery County. MSEC is seeking to amend its application to provide water service requested by the landowner in an area with no current retail water utility service. The affected service area requested includes approximately 40 acres and 0 customers. MSEC supplemented its application on August 23, 2018.

On November 28, 2018, the Administrative Law Judge (ALJ) issued Order No. 4, finding MSEC's proof of notice sufficient and setting a deadline of January 11, 2019, for Staff to provide final maps, certificates, and tariffs (if applicable) to MSEC for review and consent. Because Staff requires additional time to request information from MSEC before requesting final maps, Staff respectfully requests that the ALJ extend the procedural schedule by 30 days. Staff is authorized to represent that MSEC is unopposed to the extension.

II. PROCEDURAL SCHEDULE

In accordance with Staff's request for extension, Staff proposes the following supplemental procedural schedule:

Staff respectfully requests the entry of an order adopting the above proposed procedural schedule.


