**COMMISSION STAFF'S REQUEST FOR AN EXTENSION**

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Staff's Request for an Extension. In support thereof, Staff shows the following:

On July 2, 2018, Shelcon Services (Shelcon) and Crest Water Company (Crest) (collectively, Applicants) filed an application for approval of a sale, transfer, or merger of facilities and Certificate of Convenience and Necessity (CCN) rights in Tarrant County, Texas. Specifically, Applicants entered into an agreement for the purchase of Mustang Creek Estates public water system (PWS). If approved, Shelcon Services will deed the Mustang Creek Estates PWS facilities and water service area under CCN No. 13055. The total area being requested includes approximately 358 acres and 273 current customers. On July 24, 2018, Crest filed a supplement to its application in response to Order No. 1 and filed a second supplement on September 28, 2018.

On August 6, 2018, the Administrative Law Judge (ALJ) issued Order No. 2, establishing a deadline of October 4, 2018 for Staff to file a supplemental recommendation on the administrative completeness of the application. Therefore, this pleading is timely filed.

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On October 2, 2018, Crest filed a Motion for Waiver of Oath for Transferor. Because Staff is in correspondence with Crest and is awaiting its response regarding pending matters, Staff respectfully requests that the ALJ extend Staff's deadline to file its recommendation to October 11, 2018. Staff is authorized to represent that Crest is unopposed to this request.


