**DOUBLE DIAMOND PROPERTIES CONSTRUCTION CO. D/B/A ROCK CREEK'S  
UNOPPOSED REQUEST FOR EXTENSION OF TIME**

COMES NOW Double Diamond Properties Construction Co. d/b/a Rock Creek ("Double Diamond"), and files this Request for Extension of Time and would show the following:

**I. BACKGROUND**

On July 10, 2018, Double Diamond Properties Construction Co. d/b/a Rock Creek Resort (Double Diamond) filed an application to implement its approved purchased water pass-through clause. The purchased water pass-through clause will only pass through costs associated with water purchases from the Northwest Grayson Water Control and Improvement District No. 1.

Commission Staff filed its recommendation on August 14, 2018 finding the application incomplete and deficient. On August 15, 2018, Administrative Law Judge Mayson Pearson ("ALJ") filed a Notice finding the application incomplete and deficient and established certain deadlines.

On September 10, 2018, Double Diamond filed its Response to Commission Staff's Recommendation. On October 1, 2018 Commission Staff filed its Supplemental Recommendation on Administrative Completeness and Notice recommending that Double Diamond's application remains insufficient for filing. On October 4, 2018, the ALJ filed a Notice Finding the Application Incomplete and Deficient; and Establishing an Opportunity to

Cure recommending that Double Diamond file supplemental information to cure the deficiencies in the application by October 30, 2018. This extension request is, therefore, timely.


## **II. REQUEST FOR EXTENSION**

Pursuant to 16 Texas Administrative Code §22.4(b), Double Diamond may request that the time allowed for filing any documents be extended for good cause. Double Diamond is requesting additional time to complete its responses to the deficiencies noted by Commission Staff. Commission Staff has indicated it does not oppose this request. Double Diamond requests that its deadline to file supplemental information to cure the deficiencies in the application be extended to November 9, 2018.

## **III. PRAYER**

Double Diamond respectfully requests the issuance of an order extending the deadline for filing supplemental information to cure the deficiencies in the application until November 9, 2018.


