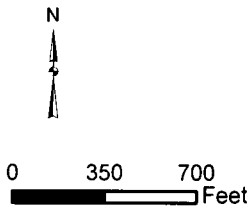


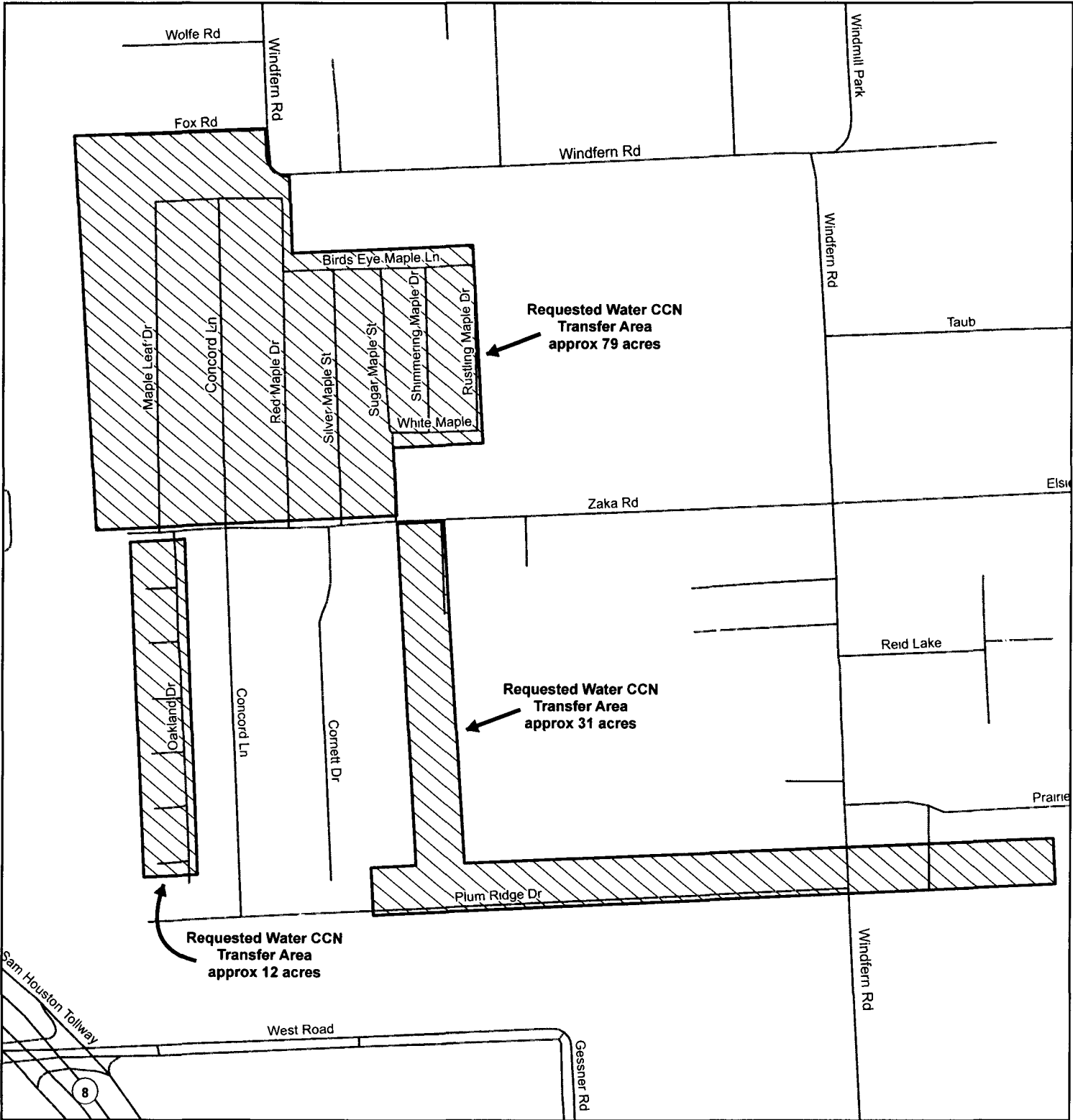
**Water Large Scale Map - Chambers and Liberty Counties**

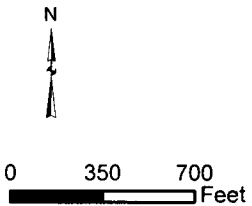

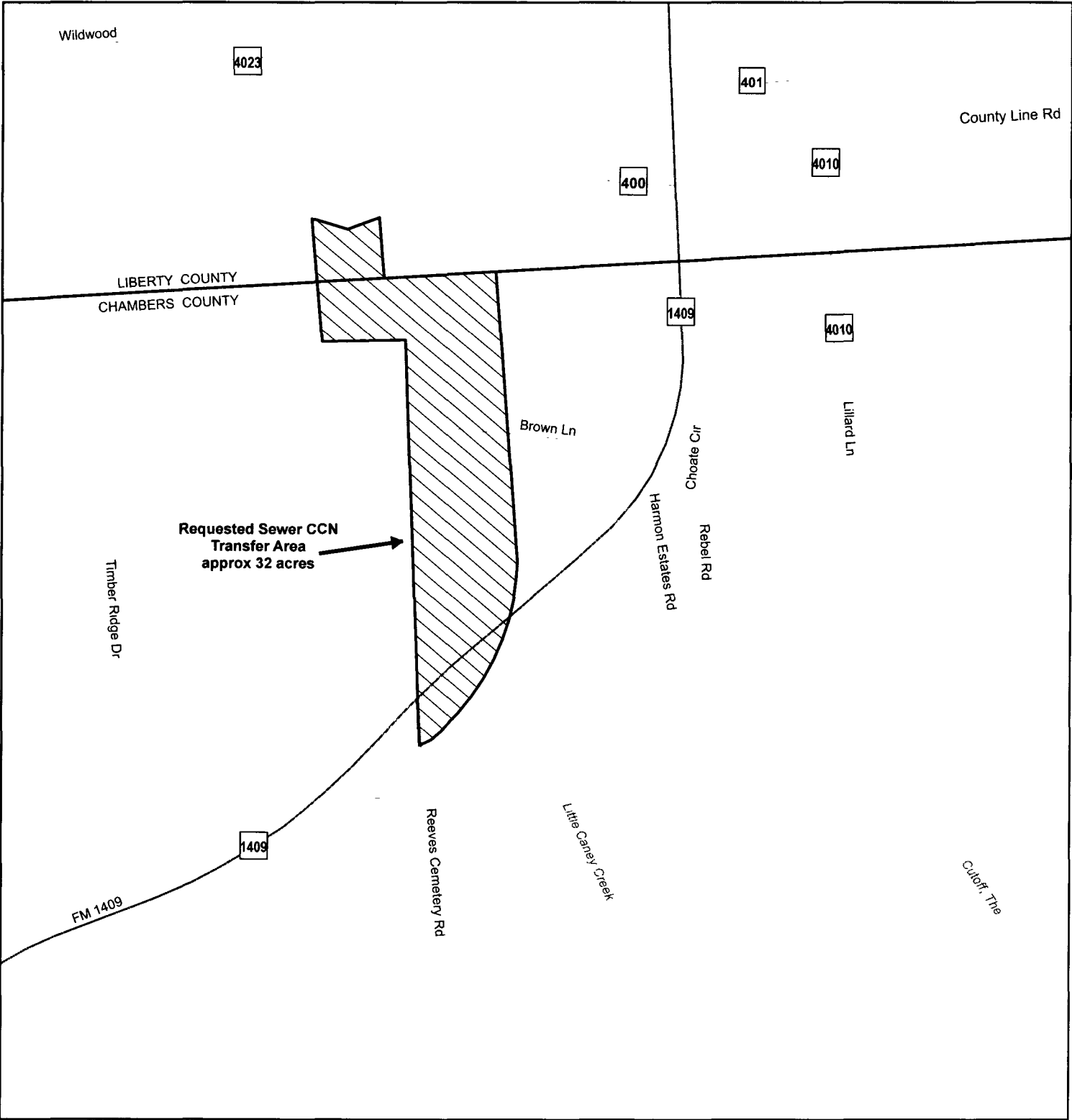

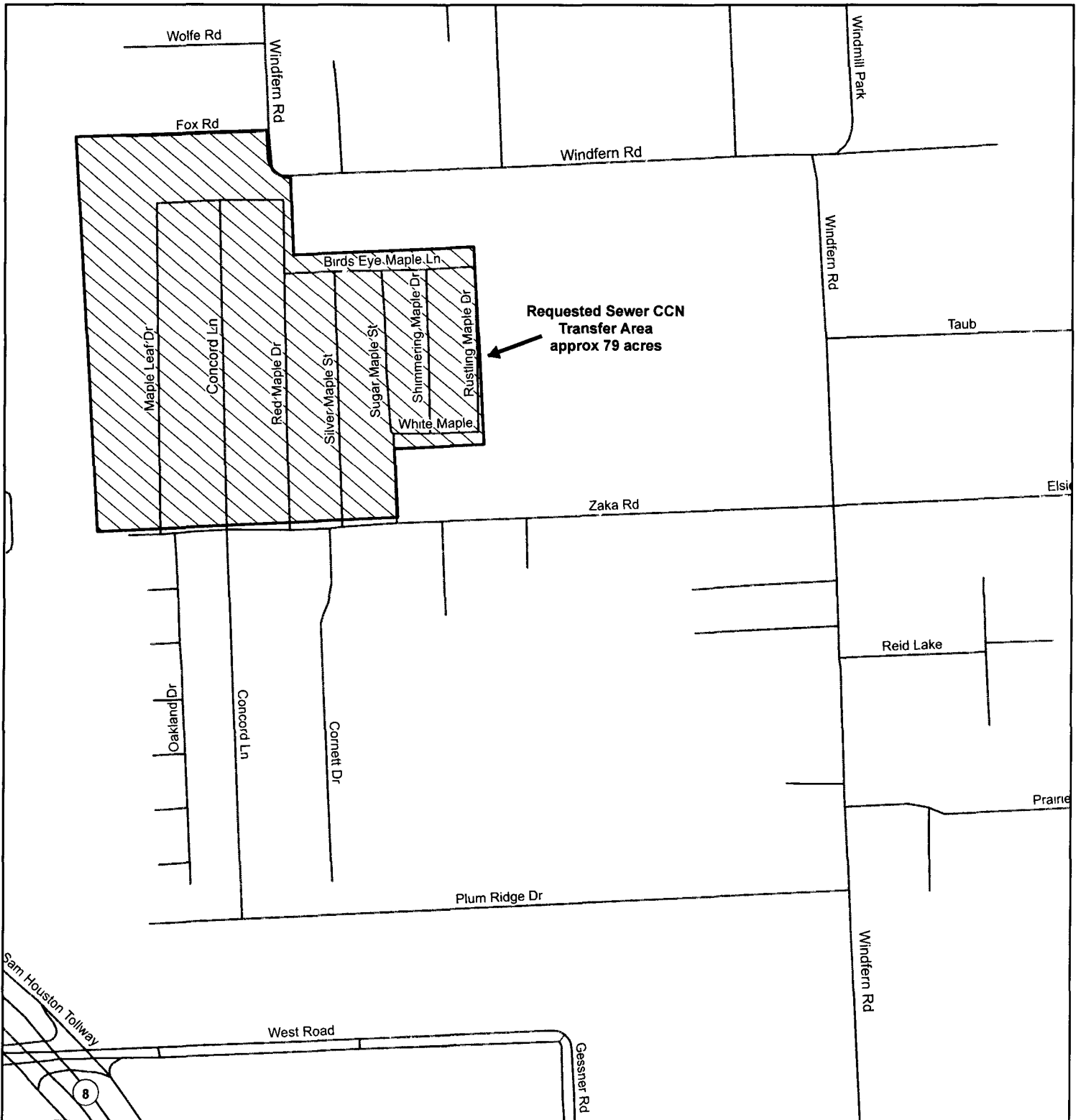

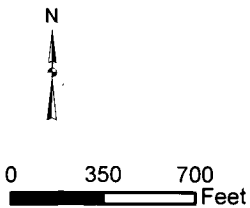
