



#### NOTICE OF APPROVAL

This Order addresses the application of CS Water Corporation, formerly known as Cedar Shores Water Corporation, for approval to change the name on its certificate of convenience and necessity (CCN) to CS Water Corporation. The Commission approves CS Water Corporation's name change.

#### I. Findings of Fact

#### <u>Applicant</u>

1. CS Water Corporation is a retail public utility that provides utility service to customers under CCN number 11441 in McLennan County, and is a domestic for profit entity registered to do business in Texas under identification number 30113937509.

#### Application

- 2. On July 25, 2018, CS Water Corporation filed an application to change the utility name under water CCN number 11441 from its former name, Cedar Shores Water Corporation.
- 3. The Commission issued CCN Number 11441 in applicant's previous name of Cedar Shores Water Corporation on May 15, 1990.
- 4. CS Water Corporation filed a certificate of amendment with the Texas Secretary of State (SOS) to change its name from Cedar Shores Water Corporation to CS Water Corporation on February 11, 2000.
- 5. The SOS issued its certificate of filing finding CS Water Corporation's name change effective on February 17, 2000.
- 6. In Order No. 2 issued on August 6, 2018, the administrative law judge (ALJ) deemed the application administratively complete.

#### **Notice**

7. On August 10, 2018, notice of the application appeared in the *Texas Register*.

#### **Evidentiary Record**

- 8. On September 26, 2018, CS Water Corporation and Commission Staff filed a joint proposed order and request to admit evidence.
- 9. In Order No. 2 issued on October 15, 2018, the ALJ admitted the following evidence into the record of this proceeding: (a) CS Water Corporation's application and all attachments filed July 25, 2018; and (b) Commission Staff's final recommendation and all attachments filed September 17, 2018.

#### Informal Disposition

- 10. More than 15 days have passed since the completion of the notice provided in this docket.
- 11. Commission Staff and CS Water Corporation are the only parties to this proceeding.
- 12. No issues of fact or law remain disputed by any party, therefore, no hearing is needed.
- 13. The decision is not adverse to any party.
- 14. On September 17, 2018, Commission Staff recommended approval of the application.

#### II. Conclusions of Law

- 1. The Commission has jurisdiction over the request under Texas Water Code (TWC) §§ 13.041(a) and 13.241.
- 2. CS Water Corporation is a retail public utility as defined in TWC § 13.002(19) and 16 Texas Administrative Code (TAC) § 24.3(59).
- 3. Notice of the request was provided in accordance with 16 TAC § 22.55.
- 4. The application was processed in accordance with the TWC and Commission rules.
- 5. Approval of the request is necessary for the service, accommodation, convenience, and safety of the public.
- 6. The requirements for informal disposition in 16 TAC § 22.35 have been met in this proceeding.

#### III. Ordering Paragraphs

In accordance with these findings of fact and conclusions of law, the Commission issues the following orders:

- 1. The Commission amends CCN number 11441 to reflect the name change to CS Water Corporation and approves the certificate attached to this Order.
- 2. Commission Staff must amend the Commission's records to reflect the name of CS Water Corporation.
- 3. The Commission denies all other motions and any other requests for general or specific relief, if not expressly granted.

# **Public Utility Commission** Of Texas

By These Presents Be It Known To All That

## **CS Water Corporation**

having obtained certification to provide water utility service for the convenience and necessity of the public, and it having been determined by this Commission that the public convenience and necessity would in fact be advanced by the provision of such service, CS Water Corporation, is entitled to this

to provide continuous and adequate water utility service to that service area or those service areas in Bosque County as by final Order or Orders duly entered by this Commission, which Order or Orders resulting from Docket No. 48545 are on file at the Commission offices in Austin, Texas; and are matters of official record available for public inspection; and be it known further that these presents do evidence the authority and the duty of the CS Water Corporation, to provide such utility service in accordance with the laws of this State and Rules of this Commission, subject only to any power and responsibility of this Commission to revoke or amend this Certificate in whole or in part upon a subsequent showing that the public convenience and necessity would be better served thereby.
