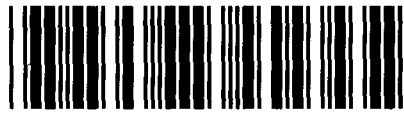

**Application for Certification and Amendment to a CCN (Name Change Only)**

PUC Central Records:

On February 11, 2000 a Certificate of Amendment for CS Water Corporation (CCN 11441), formerly known as Cedar Shores Water Corporation (CCN 11441) was filed with the Texas Secretary of State.

The effective date stamped and filed with the Secretary of State of Texas was February 17, 2000.

At this time in 2000 we contacted the TNRCC to notify of the above name change. We were told to use name CCN was originally issued for reporting purposes (Cedar Shores Water Corporation) which would not change as far as TNRCC was concerned, however new name CS Water Corporation would be considered a dba for customer billing and tax purposes if we chose.

In 2008, a like message was given to us from TCEQ when filing for new rate when presenting same query. Since 2000, our reporting typically has referred to both names having the same CCN 11441 and same PWS 180033 to avoid confusion.

Presently, in Docket 47153, our new tariff application has been submitted in the name of CS Water Corporation. This month it has come to our attention from PUC Staff discussion with us that we may change the name by way of attached application to CS Water Corporation as filed with the Secretary of State in 2000.

In order for our amended tariff to match the Certificate of Convenience and Necessity (CCN), we respectfully request that this application for a CCN name change be expedited.

Please note that all other business information for CS Water Corporation remains the same including Corporate Structure, CCN, PWS, tax ID, and contact information. Please find attached PUC application for name change only along with supporting documentation and notarized affidavit. Attachments:

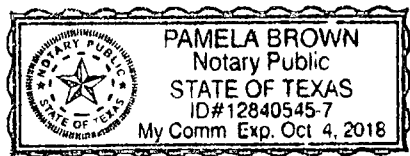

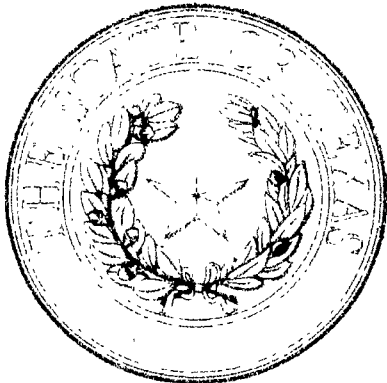

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

ARTICLE ONE

The name of the corporation is CEDAR SHORES WATER CORPORATION.

ARTICLE TWO

The following amendment to the articles of incorporation was adopted by the shareholders of the corporation on February 11, 2000. The articles of incorporation are amended to change the name of the corporation.

The amendment changes Article One of the original articles of incorporation and the full text of each provision as altered is as follows:

The name of the corporation is CS Water Corporation

ARTICLE THREE

The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100.

ARTICLE FOUR

The number of shares voted for such amendment was 100; and the number of shares voted against such amendment was 100.
