**ORDER NO. 1  
REQUIRING COMMISSION STAFF'S RECOMMENDATION**

**I. Application**

This Order addresses the July 26, 2018 application of Marilee Special Utility District (Marilee SUD) and the City of Celina (collectively, applicants) for sale, transfer, or merger of facilities and certificate rights in Collin County. If approved, a portion of the Marilee SUD water certificate of convenience and necessity number (CCN) 10150 will be transferred to the City of Celina CCN 12667. The transfer includes approximately 2,255 acres and 13 current customers.

**II. Establishing Deadline for Commission Staff's Recommendation**

Commission Staff must file on or before August 27, 2018, a recommendation regarding administrative completeness of this application,<sup>1</sup> whether additional notice may be required to comply with the applicable rules, and propose a schedule for processing.

The Commission will submit notice of this application for publication in the *Texas Register*.

**III. Filings**

Unless otherwise specified, an original and ten copies of documents relating to this proceeding must be filed with the Commission filing clerk.<sup>2</sup> A copy of each document filed with the Commission must also be served on all parties.<sup>3</sup> Filings can be accessed on the PUC Interchange, <http://interchange.puc.texas.gov>.


All parties must provide their current addresses, telephone and fax numbers, if available, to all other parties and the Commission by filing and serving all parties with such information. Each party must provide the Commission and all parties with updated address, telephone, and fax information if such information changes. The telephone and fax numbers will be placed on the service list for this proceeding. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

#### **IV. Ex Parte Communications**

*Ex parte* communications with the administrative law judges and presiding officer (collectively, ALJs) are prohibited.<sup>4</sup> Parties must communicate with the ALJs only through written documents filed with the Commission's filing clerk and served on all parties. Questions concerning this order or any other order must be submitted in writing, filed with the Commission, and served on all parties of record.
