COMES NOW, the West Travis County Public Utility Agency (the "PUA"), by and through its undersigned attorneys of record, and files this Consent to Map and Certificate ("Consent").

I. BACKGROUND

On July 31, 2018, the PUA and the City of Austin ("City") (the PUA and City are collectively, the "Applicants") filed an application ("Application") at the Public Utility Commission ("Commission") under Texas Water Code § 13.248, requesting that the Commission amend the Applicants' certificates of convenience and necessity ("CCN") to reflect the transfer a portion of the City's water CCN No. 11322 to the PUA's water CCN No. 13207. On November 15, 2018, Commission Staff transmitted an amended map and certificate to the PUA by email, which is attached hereto as Exhibit A. This correspondence directed the PUA, on or before November 30, 2018, to review the amended map and certificate and respond to Commission Staff regarding its consent thereto. Therefore, this Consent is timely filed.
