Cash and other good and valuable consideration.

Transferred Assets:

All of Seller's undivided interest in the personal property owned by Seller and which is dedicated to the operation and/or ownership of that certain water system described in the Texas Water Code §13.301 Sale, Transfer and Merger Application ("STM") through the Public Utility Commission of Texas ("PUC"), with such proceeding assigned Docket No. 48565, whether held in fee simple, by easement, lease or otherwise, exclusively related to the provision of retail potable water service to current and future property owners located in the Gap Water System in Taylor County, Texas, (the "System"); said personal property being described in that certain Asset Purchase Agreement dated June 18, 2018 (the "Asset Purchase Agreement"), specifically as described in the attached Schedule 1.1 and including the following:

- (a) all the land, buildings, pipes, pipelines, wells, pumping stations, storage tanks, standpipes, fire hydrants, flush valves, plants, structures, improvements, fixtures, rights-of-way, rights, uses, licenses and easements owned by Aqua, or in which Aqua has an interest, and all hereditarnents, tenements and appurtenances belonging or appertaining thereto, utilized exclusively for the operation of the System;
- (b) all machinery, equipment, tools, furniture, furnishings, leasehold improvements, goods, and other tangible personal property utilized exclusively for the operation of the System;
- (c) all rights of Aqua under any transferable written or oral contract, easement, license, agreement, lease, plan, instrument, registration, permit, certificate, CCN, or other authorization or approval of any nature, or other document, commitment, arrangement, undertaking, practice or authorization, relating exclusively to the System;
- (d) all rights and choses in action of Aqua arising out of occurrences before or after the Closing relating exclusively to the System; and
- (e) files, records, plans, contracts, customer and supplier lists and property records related exclusively to the System.

PROVIDED, HOWEVER, that the Parties expressly agree that the Transferred Properties do not include the following:

- (a) any and all customer water service lines that run from outside the meter box to each individual residence, commercial or industrial structure served by the System;
- (b) all piping and fixtures internal to each individual customer's structure;
- Aqua's cash on hand and accounts receivables for customer billings for any services provided by Seller prior to the date of Closing, including customer deposits;
- (d) equipment and tools owned or leased by Seller that are not used exclusively for the operation or service of the System;
- (e) all Seller vehicles; and
- (f) all other Seller assets not utilized exclusively for the operation or service of the System, unless otherwise specifically listed in Schedule 1.1 attached hereto.

Seller, for the Consideration recited above, hereby, sells, transfers, and delivers the Transferred Properties to Buyer, together with all and singular the rights and appurtenances thereto in any way belonging, to have and to hold the Transferred Properties to Buyer and Buyer's employees, agents, representatives, successors, and assigns forever. Seller binds Seller and Seller's heirs and successors to warrant and forever defend all and singular the title to the Transferred Properties to Buyer and Buyer's employees, agents, representatives, successors, and assigns against every person whomsoever lawfully claiming or to claim the same or any part thereof, by, through, or under Seller, but not otherwise.

When the context requires, singular nouns and pronouns include the plural.



SUBMISSION OF CLOSING DOCUMENTATION

COME NOW, Aqua Texas, Inc. ("Aqua") and the Town of Buffalo Gap ("Town") (collectively, the "Applicants") and file this Submission of Closing Documentation to evidence the Applicants' conclusion of this transaction.

On August 2, 2018, the Applicants filed an application for Sale, Transfer or Merger of Facilities and Certificate Rights in Taylor County related to the Gap Water System. On November 28, 2018, the Commission issued Order No. 4 Approving Transaction to Proceed, to be concluded by May 28, 2019. Order No. 4 required the Applicants to submit monthly updates regarding the status of efforts to conclude the transaction, address customer deposits, and submit documents evidencing same beginning on December 20, 2018, and each month thereafter. On May 23, 2019, the Commission entered Order No. 5 Granting Request for Extension allowing the Applicants until November 25, 2019 to conclude the transaction. On November 25, 2019, the Commission entered Order No. 7 Granting Request for Extension allowing the Applicants until May 25, 2020 to conclude the transaction. On May 22, 2020, the Commission entered Order No. 8 Granting Request for Extension allowing the Applicants until September 30, 2020 to conclude the transaction.
