DISTRICT AND MUSTANG RESPONSE TO COMMISSION STAFF REQUEST FOR INFORMATION

STAFF REQUEST: On page 2 of the Interlocal Agreement for Property Transfer and Allocation of Water and Wastewater Service Areas, the agreement defines "District's CCNs" to mean water CCN No. 12967 and wastewater CCN No. 20888. These CCN numbers are not issued to the District. The petition filed with the Commission, however, references the District's actual CCNs – 13021 and 20923. Please clarify the actual CCN numbers that are the subject of the agreement and the petition.

Response: The actual CCN numbers that are the subject of the agreement and the petition are CCN Nos. 13021 and 20923. The CCN numbers referenced in the definition of "District's CCNs" in the agreement are typographical errors. The agreement should have referenced CCN Nos. 13021 and 20923. The typographical errors do not affect the substance of the agreement. The intent of the parties to the agreement with regard to what CCN area is being transferred is shown clearly by Exhibit B to the agreement, which shows the portion of CCN Nos. 13021 and 20923 that are to be transferred. Additionally, the intent of the parties is shown by the petition in this docket, which both lists the appropriate CCN numbers and contains two maps (Exhibits 3.A. and 3.B.) that show the portions of CCN Nos. 13021 and 20923 that are being transferred from the District to Mustang.
