COMMISSION STAFF'S FINAL RECOMMENDATION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Final Recommendation in response to Order No. 5 and would show the following:

I. BACKGROUND

On August 3, 2018, Denton County Fresh Water Supply District No. 10 (the District) filed a petition for approval of an agreement with Mustang Special Utility District (Mustang SUD) under Texas Water Code (TWC) § 13.248 and 16 Texas Administrative Code (TAC) § 24.253 (formerly 16 TAC § 24.117). As part of that agreement, a portion of certificated service area that is currently dually certificated to the District and Mustang SUD would be decertified from the District's water and sewer certificates of convenience and necessity (CCN) Nos. 13021 and 20923.

On October 17, 2018, Order No. 5 was issued, deeming notice sufficient and establishing a deadline of January 11, 2019, for Staff to file a final recommendation on the application. This pleading is therefore timely filed.

II. RECOMMENDATION

As detailed in the attached memorandum from Fred Bednarski III in the Commission's Water Utility Regulation Division, Staff has reviewed the application and all supplemental information that has been provided and recommends that the application be approved. The certificates and maps that the District and Mustang SUD consented to in their consent forms filed

on December 10 and 11 are attached. The parties will file a joint proposed findings of fact and conclusions of law in accordance with the procedural schedule established in Order No. 5.

III. CONCLUSION

For the reasons discussed above, Staff recommends that the application be approved.

Code § 13.248 in Denton County

On August 3, 2018, Denton County Fresh Water Supply District No. 10 (Denton County FWSD 10) filed a petition with the Public Utility Commission of Texas to decertify a portion of its water Certificate of Convenience and Necessity (CCN) No. 13021 and its sewer CCN No. 20923 in Denton County pursuant to Texas Water Code (TWC) § 13.248. The area to be decertified is currently dually certificated, for water and sewer, with Mustang Special Utility District's (Mustang SUD) water CCN No. 11856 and sewer CCN No. 20930.

Denton County FWSD 10 and Mustang SUD have agreed for Mustang SUD to be singly certificated in the requested area and to serve the existing customers. The total area includes approximately 849 acres and 2,452 current customers.

Notice was provided on or about October 2, 2018, to all affected customers in the area subject to this application. No parties filed for intervenor status.

The application meets all of the statutory requirements of TWC Chapter 13 and the 16 Texas Administrative Code Chapter 24 rules and regulations. Staff recommends approval of the application.

The Applicants consented to the attached map and certificates on December 10, and December 11, 2018.

Based on the above information, Staff recommends that:

- The application be approved and an order issued; and
- The attached maps and certificates be provided to the Applicants.

Staff further recommends that the Applicants file certified copies of the CCN maps along with a written description of the CCN service areas in the county clerk's office pursuant to TWC §§ 13.257 (r)-(s).






