JOINT PROPOSED ORDER AND REQUEST TO ADMIT EVIDENCE

Trailblazer Wind, LLC (Trailblazer) files this Joint Proposed Order and Request to Admit Evidence, including findings of fact, conclusions of law, and ordering paragraphs. Staff (Staff) of the Public Utility Commission of Texas (Commission) has reviewed and agreed to the Joint Proposed Order, which is attached as Attachment 1. This Joint Proposed Order is timely filed on or before September 25, 2018.

I. REQUEST TO ADMIT EVIDENCE

The parties jointly request to admit the following evidence in the record of this proceeding: (a) the application of Trailblazer Wind, LLC Under § 39.158 of the Public Utility Regulatory Act and all attachments thereto (the Application), filed August 9, 2018; (b) Staff's Recommendation on Final Disposition and all attachments thereto, filed September 18, 2018; and (c) Notice of the Application published in the *Texas Register*, filed August 14, 2018.

II. PROPOSED ORDER

The parties jointly request that the attached Proposed Order be adopted. The Proposed Order would grant Trailblazer's application for approval of its issuance of passive Class B interests to JPM Capital Corporation and Wells Fargo Central Pacific Holdings, Inc. (Investors). Trailblazer and Investors propose to close the Transaction on or before December 10, 2018, following receipt of all required approvals.

The docket was processed in accordance with applicable statutes and Commission rules. Notice of the Application was provided to interested parties. No protests and no requests for hearing were filed. Therefore, Trailblazer and Staff are the only parties to this proceeding.

III. CONCLUSION

Staff has reviewed the Application and recommends its approval. The parties therefore respectfully request that the Commission adopt the attached Joint Proposed Order, including the

proposed findings of fact and conclusions of law, as well as grant the admittance of the specified evidence.
