**COMMISSION STAFF'S UNOPPOSED REQUEST FOR EXTENSION OF DEADLINE  
TO FILE FINAL RECOMMENDATION**

**COMES NOW** the staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and requests an extension of the deadline for Staff to file its Final Recommendation in this matter. In support thereof, Staff shows the following:

Order No. 3 established a deadline of November 26, 2018, for Staff to file its final recommendation in this matter. In light of the staffing shortages occasioned by the Thanksgiving holiday, Staff requests that its deadline for filing a final recommendation be extended by one week, until December 3, 2018. This would also necessitate extending, to December 10, 2018, the Applicant's deadline to respond to the final recommendation. This request is not made for purposes of delay, but so that justice may be done. The Applicant, Raymond Martin, does not oppose this request.

For the reasons stated above, Staff respectfully requests that its deadline for filing a final recommendation be extended until December 3, 2018 and the Applicant's deadline to respond to the final recommendation be extended until December 10, 2018.


