ORDER CALLING FOR ELECTION OF OFFICIALS FOR THE
TOWN OF CUT & SHOOT

ON THIS the 14th day of April, 1969, it appearing to the County Judge of Montgomery County, Texas that pursuant to and under and by virtue of the various statutes and articles comprising Chapter 2 "Towns and Villages" of Title 28 of the Revised Civil Statutes of Texas as amended, an election was held on the 5th day of April, 1969 on the question of the incorporation of the Town of Cut & Shoot, and a majority of the votes cast in such election having been in favor of incorporation, and the officers holding such election having made return thereof to the County Judge within ten days after the same was held and within twenty days after the receipt thereof entry was made upon the records of the Commissioners' Court that the inhabitants of the Town of Cut & Shoot are incorporated within the boundaries thereof, which boundaries are designated in such entry, and a certified copy of such entry together with a plat of the Town of Cut & Shoot having been recorded in the Deed Records of Montgomery County, Texas, and all prerequisites of law having been complied with;

NOW, THEREFORE, by virtue of the authority vested in me under the laws of the State of Texas, I, Jonathan Thornberry, County Judge of Montgomery County, Texas, do hereby order that on the 17th day of May, 1969, at the Cut & Shoot Volunteer Fire Department Building an election shall be held for the purpose of enabling the qualified voters residing within the boundaries of the said Town of Cut & Shoot to elect a Mayor, a Marshal, and five (5) Aldermen. The polls shall be opened and held at such place for such election at seven o'clock A. M.

and closed at seven o'clock P. M. Every person who has attained the age of twenty-one (21) years, and who has resided within the limits of said Town of

Cut & Shoot for six (6) months next preceding the day of election and is a

qualified elector under the laws of the State of Texas shall be entitled to vote at such election.

IT IS FURTHER ORDERED that

hereby is appointed as the officer to preside at such election, and such officer is hereby directed to select two (2) judges and two (2) clerks to assist in holding the election; such officer shall prepare a sufficient number of ballots for all resident voters within the boundaries of the said Town of Cut & Shoot; such officer, judges and clerks shall open the poll at the above designated time and place and close the poll at the above designated time. The Sheriff of this County, or the officer conducting such election, shall give public notice of such election by posting advertisement thereof at three (3) public places in said Town of Cut & Shoot at least thirty (30) days prior to the day of election; and such officer and persons holding the election shall, within the legal time, make due return of all votes cast for and against the candidates for elective office in said Town to the County Judge of Montgomery County, Texas.

ORDER DECLARING RESULTS OF AN ELECTION HELD IN THE
TOWN OF CUT & SHOOT, APRIL 5, 1969

WHEREAS, an election was held in the Town of Cut & Shoot on the 5th day of April, A. D. 1969 to determine whether the hereinabove described territory should be incorporated for municipal purposes to be known as the Town of Cut & Shoot, and returns of said election were duly made and it appearing from said returns that a majority of the votes were cast at said election in favor of incorporation, there being one hundred one (101) votes for incorporation and thirty-one (31) votes for no incorporation.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that said election resulted in favor of such incorporation; and I, Jonathan Thornberry, County Judge of Montgomery County, Texas, do hereby declare the inhabitants of said territory hereinafter described as duly incorporated for municipal purposes to be known as the Town of Cut & Shoot.

The territory so incorporated is described by metes and bounds on the attached EXHIBIT "A", which said EXHIBIT "A" is made a part hereof for all purposes.

This order is made and entered upon the records of the Commissioners' Court of Montgomery County, Texas, this the 14th day of April, A. D. 1969, and a certified copy of the same, together with a copy of the field notes of said territory incorporated shall be incorporated in the proper records of deeds of said Montgomery County.
