AGREED MOTION TO AMEND PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff) and W.E. Vlasek (Applicant), by and through counsel (collectively, the Parties) and file this Agreed Motion to Amend the Procedural Schedule in this case as set forth in SOAH Order No. 9. In support thereof, the parties show the following:

1. On October 23, 2019, the Honorable Administrative Law Judge (ALJ) issued SOAH Order No. 9 modifying the previously-adopted procedural schedule and setting the hearing in this case for November 20 and 21, 2019.

2. The Applicant just discovered that the court reporting service that the Applicant planned to use for the hearing does not have any court reporters available on November 20 and 21, 2019.

3. Also, the Applicant and Staff are meeting on Monday, November 18, 2019, to discuss the possible settlement of this case.

4. In order to assure that a court reporter will be available to record the hearing, and in order to afford the parties time to meet on Monday, November 18, 2019, and possibly another date before the hearing to try to settle this case, the Parties request that the Honorable Administrative Law Judge reschedule the final hearing in this case on December 4 and 5, 2019.

5. The Applicant understands that counsel for Staff currently has a hearing set on December 4 and 5, 2019, and also understands that the hearing may get moved to another date. If Staff's hearing is not moved, the Parties will make a separate filing proposing hearing dates in early January 2020.

6. The Parties agree to a day-for-day extension of the effective date for the Applicant's rate equal to the number of days between November 21, 2019, and the new hearing date for this case once it is determined.




