DEFINITIONS

 - a) Shalako Estates;
 - b) Canyon Springs;
 - c) Mary Meade;
 - d) Rustic Hills; and
 - e) Village West
- Staff RFI 4-3 Please provide allocation schedule to allocate costs or expenses to the utility systems and affiliates, if any.
