TEMPORARY MANAGER'S SUMMARY REPORT

Lynn Sherman is pleased to provide the following summary report relating to his time as temporary manager of Blue Cereus, LLC ("Blue Cereus") and its retail water systems.

INTRODUCTION

Mr. Sherman currently serves as the second temporary manager of Blue Cereus¹ and its two retail systems: i) San Pedro Village; and ii) La Caleta Estates. San Pedro Village has 25 active connections, and La Caleta Estates has approximately 77 active connections.

Each retail system is served by a separately owned wholesale water supply system from a nearby groundwater well: i) San Pedro Canyon Water Resources provides wholesale service to San Pedro Village; and ii) Seguro Water Co. LLC provides wholesale service to La Caleta Estates. Originally, there was no bifurcation of wholesale and retail service for either system, and each was operated as a stand-alone retail system with its own well. However, the then-partners elected to separate and divided the systems into two independent sets of retail and wholesale systems, with one partner owning the retail systems, and the other partner owning the groundwater wells and having a contractual right to provide wholesale service to the retail system connected to each well. Unfortunately, the wholesale water supply contracts that served as the basis for this retail/wholesale arrangement expired by their own terms on December 31, 2014 and have not been renewed.

Mr. Sherman's temporary managership began on March 15, 2019. He succeeded Jane Whaley, whose appointment as temporary manager on August 30, 2018 originated the temporary managership of Blue Cereus, L.L.C. In addition to serving as temporary manager, Ms. Whaley also served as the operator of Blue Cereus's two retail systems through her company "WH2O LLC", which she had done prior to serving as temporary manager and continues to do.

Upon Mr. Sherman's appointment, the primary problems facing the Blue Cereus systems were: 1) the previous temporary manager's failure to issue monthly bills to retail customers, and: 2) an ongoing dispute between Blue Cereus and its wholesale providers over the appropriateness of amounts paid for wholesale service since the wholesale contracts expired on December 31, 2014 and the appropriate amount to be paid on an ongoing basis.

OVERVIEW OF ACTIVITIES

Since being appointed temporary manager, our primary focus has been to:

- Re-commence invoicing;
- Re-establish contact and trust with customers;
- Increase collections;
- Re-establish monthly payments to the wholesale providers; and
- Begin paying down accumulated accounts payable owed to vendors.

¹ Blue Cereus, LLC is owned by Jimmy Alan Hall. At this point, we do not have reason to believe that Mr. Hall has exhibited any impropriety in his handling of the retail utilities' funds, and we are still evaluating to what extent, if any, money was used to pay Mr. Hall's personal fees or make other "low priority" payments before satisfying outstanding invoices from vendors. Mr. Hall has worked very well and professionally with us, and, to our knowledge, he has fully complied with the Commission's existing order to not interfere with our management of the utilities.



TIME COMMITMENT

The work associated with this temporary managership has been significant. Since being appointed temporary manager, I have enlisted the help of my associate, Reid Barnes, and an intern, Zach Kelly, to assist in matters relating to Blue Cereus and its retail systems. Each of us has expended a significant amount of time addressing issues related to Blue Cereus and bringing operational stability back to the its systems and customers. I spend approximately 10 to 12 hours a week on issues related to the Blue Cereus, and Reid Barnes has committed in excess of seventy-five (75) hours overall working on compliance issues (including pre-existing notices of violation), reporting requirements, and other matters. After a couple of months, we determined even more regular attention was required, so we brought Zach Kelly on board. Since joining our team, Zach has worked diligently to reach out to each customer of each system (often multiple times) to discuss Blue Cereus' issues and our efforts to address them. Zach has been working approximately 30 hours per week on Blue Cereus matters and to date has made approximately 330 calls and sent approximately 350 emails to Blue Cereus customers, including individualized letters to almost every customer itemizing the amounts billed to them and amounts still due and owing. All told, this has amounted to over 200 hours devoted to customer correspondence alone.

METER READING AND RETAIL BILLING

Since being appointed temporary manager, we have worked closely with Jane Whaley, in her capacity as the operator of the retail systems. After an initial rough start, Ms. Whaley has demonstrated a revived energy and has become more responsive and dependable. Moreover, she has been conducting her work without charge as a means of "making up" for failing to send out invoices during her time as temporary manager.

Ms. Whaley (through her company, WH2O LLC) has continued to read the retail meters, and we have worked with her to improve the regularity and timeliness of her meter-reading and reporting of results.² As of this past month, we now have her reading the retail meters on the same day the wholesale meters are read, so we can better compare and assess retail vs. wholesale meter-reading results to address the calibration and water loss issues addressed below.

Regarding retail customer billing, however, we continued to experience significant difficulties with timely preparation and distribution of monthly bills. As a result, after a couple of months of unsatisfactory results, Ms. Whaley helped us locate a local resident, Mary Riggs, to serve as her replacement. Ms. Riggs has proven to be very effective at timely invoicing, and we now contract directly with her.

COLLECTIONS

Following Ms. Whaley's appointment as temporary manager on August 30, 2018, Blue Cereus' customers were not invoiced for a period of approximately six (6) months (i.e., until Ms. Whaley was replaced as the temporary manager). Despite the lack of invoicing, some customers still submitted payment for various estimated amounts. Some of these payments were made payable to the operator "WH2O LLC" and were deposited into its account at Texas Community Bank in Del Rio, and others were made payable to "Blue Cereus, LLC" and were deposited into its account at Ozona Bank in Wimberley. Since assuming the responsibilities of temporary manager, we have done our best to consolidate all the deposits made during this time into a single account set up for "Lynn Sherman – Temporary Manager of Blue Cereus, LLC" at Frost Bank. However, transitioning customers to make and address their payments to the current temporary manager, rather to "WH2O LLC" or "Blue Cereus", has been much more difficult. While most customer payments are now properly made out and addressed to the current

temporary manager (as specified in our invoices and customer communications), some are still made out and/or mailed to either "WH2O LLC" or "Blue Cereus". In these instances, we have made arrangements with WH2O LLC (the operator) and Blue Cereus (the utility) to deposit the checks into their accounts and then transfer the funds into the current temporary manager's account at Frost Bank.

As indicated above, invoicing and increased collections has been our primary focus since being appointed temporary manager. To that end, we have made serious efforts to personally reach out to every customer to explain the current circumstances of the temporary managership, answer questions, confirm contact information, and work out payment arrangements to bring each customer current. At this point, either Zach Kelly, Reid Barnes, or myself have personally called, emailed, and/or otherwise corresponded with every customer of Blue Cereus' two retail systems, and collections have increased as a result. Moreover, within the past month, individualized letters and/or emails have been delivered to each retail customer itemizing: i) the invoices they should have received since the temporary managership began; ii) amount that they have paid with respect thereto; and iii) the amount that remains due and owing. Collections have increased significantly since.

GROSS DISPARITY IN RETAIL AND WHOLESALE METER READINGS

Historically, there have been wide-ranging differences in the total of the meter readings taken by the retailer and the meter readings taken by the wholesaler for both San Pedro Village and La Caleta Estates. For reference, we have attached spreadsheets reflecting historical wholesale and retail meter readings for both systems. Until the causes of these disparities and the system-specific issues addressed below are resolved, it is virtually impossible to determine with any accuracy how much water is actually delivered and chargeable to Blue Cereus and its retail systems and how much may or may not be owed for past deliveries.

San Pedro Village's Wholesale Meter. It is our understanding that a new wholesale meter was installed at San Pedro Village in April of 2018. However, it appears the meter was not installed on the delivery side of the wholesaler's system (i.e., after the storage tank and at the point of delivery and sale to the retail system), as is typically done, but rather on the production side (i.e., between the wholesaler's groundwater supply well and its storage tank). The location of this wholesale meter is a significant issue because the wholesaler's storage tank leaks. In fact, some of the leaks during the temporary managership of Blue Cereus have been significant enough to drain the wholesale storage tank to the point of triggering an automatic shutdown of the system. Because the meter is placed before the water enters the wholesale storage tank, the wholesale meter readings for San Pedro Village effectively charge the retail customers for these losses, which they should not be the case. Moreover, the location of the wholesale meter makes it is impossible to accurately determine how much water is actually delivered and sold to the retail system.

La Caleta Estates' Wholesale Meter. It is our understanding that the wholesale meter at La Caleta Estates was repaired in 2012 after initially being installed improperly and that it has not been calibrated since. Given the often-significant disparities between the wholesale meter readings and the total retail meter readings in La Caleta Estates, it is our strong inclination that the wholesale meter should be re-calibrated.

Retail Meters for Both Systems. According to the systems' operator, the retail meters for both retail systems are, in some cases, over 10 years old. The age of these meters also could account for some of the wholesale vs. retail meter reading disparities.

In an effort to better determine the extent of the meter reading disparities, we have asked our operator to read the retail meters on the same day the wholesale meters are read (i.e., the last day of the month), and

she has assured us that she will make every effort to do so. She started last month, but since the previous month's wholesale and retail meter readings were done on different days, it was not a true "apples-to-apples" comparison. However, going forward, it should be.

All of these issues, and how to address them, will be addressed and hopefully resolved through the discussions with the wholesalers which are scheduled to commence within the next few weeks, as further addressed below.

PAYMENTS TO WHOLESALERS

Since assuming the responsibilities of temporary manager, we have paid both the base fee and volumetric charges for each invoice submitted by the wholesaler, save and except the most recent month's invoices.

Base Fees. It is worth noting that the base fee payments that we have made are non-escalated. By way of explanation, our standing agreement with the wholesalers is that, during our service as temporary manager, we will pay in accordance with the contracts between the wholesalers and Blue Cereus that were previously in effect and expired at the end of 2014. The expired contracts provided that the volumetric rates were to increase annually in accordance with a specified escalation percentage; however, no such escalation applied to the base fees. Nevertheless, recent invoices from the wholesalers have included an escalation of the base fee, which we ignored when we made our base fee payments, and the wholesalers have since agreed (through their attorney) is not owed and will not appear on future invoices.

Volumetric Charges. In addition, relative to the most recent month's invoices and going forward until an agreement is in place with the wholesalers as to how to reconcile the disparities in meter readings (addressed above), we have elected to pay only the base fees of each invoice, and, instead of paying any volumetric charges (which are predicated on meter readings), we will begin to pay down unpaid base fee amounts for the months invoiced during Ms. Whaley's temporary management. Once an agreement regarding meter readings and the volumetric charges related thereto is reached, we will begin paying unpaid volumetric charges from funds remaining after payment of current invoices (both the base fee and volumetric charges) are made in full.

NOTICES OF VIOLATION AND COMPLIANCE ISSUES

Blue Cereus has received several notices of violation ("NOVs") from the TCEQ for failing to test for disinfectant level and/or submit quarterly operating reports related thereto prior to the commencement of the current temporary managership in March of 2019. Specifically, NOVs were received for failure to submit DLQORs for both La Caleta Estates and San Pedro Village for the 3rd quarter of 2018 and the 1st quarter of 2019. Ultimately, we determined that the tests were in fact completed and submitted on a timely basis, but were not recorded as such due to a lapse either between our operator and the reporting system or the reporting system and the TCEQ. Nevertheless, DLQORs for both retail systems have since been successfully submitted to and recorded by the TCEQ, and the appropriate notices are being sent to each customer notifying them of the issue and what has been done to resolve it.

PRIMARY OBJECTIVE MOVING FORWARD: RESOLVING THE DISPUTE BETWEEN BLUE CEREUS AND ITS WHOLESALERS

Our invoicing and collections efforts have enabled us to resume current and regular payments to the wholesalers (as qualified above) and will allow us to commence payments on past due amounts incurred during the tenure of the previous temporary manager. Nevertheless, the debt claimed against Blue Cereus by the wholesalers for periods pre-dating to the initiation of the temporary managership is of such a size that it is doubtful that Blue Cereus will ever be able to pay it off from the systems' revenues, even if

collections reach 100%. Moreover, we do not believe that we have the authority, as a temporary manager, to resolve these issues on Blue Cereus' behalf, nor do we believe they can be resolved without either:

- i) a settlement agreement between the Blue Cereus and its wholesalers;
- ii) a judicial decision as to the competing legal issues involved (for which we see merits on both sides); or
- iii) appointing a receiver for Blue Cereus with the authority and for the purpose of placing Blue Cereus into bankruptcy (which would both eliminate and/or otherwise address any outstanding debt to the wholesalers and result in the retail systems coming under new ownership).

After four months, it is clear that we cannot restore the Blue Cereus retail systems to a point they can be taken out of temporary managership without resolving the overall dispute between Blue Cereus and its wholesalers,³ and, to that end, the only option currently available to us is the first: settlement. Therefore, we have spoken with the principals of both Blue Cereus and its wholesalers, and we intend to convene settlement discussions with them over the next couple of months.

As an important side note, one of the ways in which the ongoing relationship issues between Blue Cereus and its wholesalers might be resolved is for Blue Cereus to obtain its own water supplies or connect to another wholesale provider. To that end, we have had numerous conversations with Jimmy Alan Hall, Blue Cereus's principal, about drilling a new groundwater well for each retail system or inter-connecting them to adjacent retail providers as a way of securing Blue Cereus' own source of water supply. If Mr. Hall is able secure other water supplies for Blue Cereus's retail systems, the dispute between Blue Cereus and its wholesalers would cease to exist as to future obligations, and the parties could litigate or agree to a settlement as to past due amounts, if any. Mr. Hall has indicated that he has secured at least one potential well site through the execution of a letter of intent and is in the process of exploring other alternative sites for both retail systems. In addition, Mr. Hall has priced and explored inner-connections with at least one adjacent retail provider. Even if Mr. Hall is successful in obtaining alternate water supplies for Blue Cereus's retail systems, we are not certain that a complete transition away from the existing wholesalers can occur within the next six (6) months, and we certainly do not believe it will occur without resolving the other outstanding issues between the parties.


If our settlement efforts prove unsuccessful and Mr. Hall is unable to timely secure alternative supplies for Blue Cereus' systems, we will likely submit an immediate request to the PUC suggesting that it appoint a receiver with the authority (if not the directive) to place Blue Cereus into bankruptcy.

³ It may be important to note that, in our opinion, both of the parties - Blue Cereus and the wholesalers - appear to have conducted the operational aspects of their businesses in a very professional manner historically. They certainly have been professional in their interactions with us, in our role as temporary manager. However, their interactions with each other are less than ideal, and this characterization applies with equal weight to both sides.

CONCLUSION

Given our current status with Blue Cereus described herein, we would ask the Commission to continue our appointment as temporary manager for a second term of six (6) months to allow time to continue negotiating with the wholesalers, continue exploring an alternate wholesale source, and continue bringing collections back into compliance. If these issues cannot be resolved within an additional six (6) month appointment for the temporary manager, we would strongly suggest Blue Cereus be placed into receivership at such time.
