COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for Extension.

I. BACKGROUND

On September 4, 2018, the City of Lucas (Lucas) filed an application to amend water certificate of convenience and necessity (CCN) No. 10193 in Collin County. Lucas is amending its CCN so that it reflects the actual service territory that it currently serves. The requested area includes adding approximately 3,626 acres, 2,693 current customers and no new customers.

On March 28, 2019, the Administrative Law Judge issued Order No. 6, requiring parties to file joint proposed findings of fact, including findings that address the factors in Texas Water Code § 13.246(c), and corresponding conclusions of law by May 13, 2019. This pleading is therefore timely filed.

II. STAFF'S REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires more time to work with Lucas to file joint proposed findings of fact and corresponding conclusions of law. Staff requests that the deadline for parties to file joint proposed findings of fact, including findings that address the factors in Texas Water Code § 13.246(c), and corresponding conclusions of law be extended to May 27, 2019. Staff has discussed this extension request with Lucas and they do not oppose this request for extension.

III. CONCLUSION

For the reasons discussed above, Staff respectfully requests the entry of an order consistent with the above recommendation.


