



COMMISSION STAFF'S PROPOSED LIST OF ISSUES

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Proposed List of Issues. In support thereof, Staff shows the following:

I. BACKGROUND

On September 12, 2018, Bluebonnet Hills Water Supply Corporation (Bluebonnet) and the City of Cresson (Cresson) (collectively, Applicants), filed an application for sale, transfer, or merger of facilities and certificate rights in Parker and Johnson Counties, Texas. Specifically, Cresson seeks approval to acquire facilities and to transfer water service area from Bluebonnet under water Certificate of Convenience and Necessity (CCN) No. 12290. The requested area includes approximately 436 acres and 164 connections. Applicants filed supplemental information on September 27, 2018 and December 7, 2018.

On July 22, 2019, this docket was referred to the State Office of Administrative Hearings. The Order of Referral set the deadline for parties to file a list of issues as August 8, 2019. This pleading is therefore timely filed.

II. LIST OF ISSUES

Staff recommends that the Commission adopt the list of issues from the Preliminary Order adopted in the Application of Gastonia-Scurry Special Utility District and West Cedar Creek Municipal Utility District for Sale, Transfer, or Merger of Certificate Rights in Kaufman County, Preliminary Order (June 28, 2018).
