**PARTIES AGREEMENT TO PROCEDURAL SCHEDULE AND REQUEST TO
CANCEL PREHEARING CONFERENCE**

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and with agreement from Bluebonnet Hills Water Supply Corporation, and files this Agreement to Procedural Schedule and Request to Cancel Prehearing Conference. In support thereof, Staff shows the following:

I. BACKGROUND

On September 12, 2018, Bluebonnet Hills Water Supply Corporation (Bluebonnet) and the City of Cresson (Cresson) (collectively, Applicants), filed an application for sale, transfer, or merger of facilities and certificate rights in Parker and Johnson Counties, Texas. Specifically, Cresson seeks approval to acquire facilities and to transfer water service area from Bluebonnet under water Certificate of Convenience and Necessity (CCN) No. 12290. The requested area includes approximately 436 acres and 164 connections. Applicants filed supplemental information on September 27, 2018 and December 7, 2018.

On July 22, 2019, this docket was referred to the State Office of Administrative Hearings (SOAH). SOAH Order No. 1 set September 5, 2019 as the date of the prehearing conference.

II. REQUEST TO CANCEL PREHEARING CONFERENCE

Notice documentation was filed on March 21, 2019 and July 10, 2019, providing proof that notice was mailed on March 13, 2019. To date, no motions to intervene have been filed and Staff and Applicants are the only parties. There is no jurisdictional deadline for sale, transfer, or merger applications once referred for a hearing. The parties have agreed to set a deadline of October 4,

2019 for Staff to file either a recommendation on the application or a status report on Staff's review of the application.

The parties believe that this addresses all of the issues to be taken up at the prehearing conference. Unless there is some other matter that the Administrative Law Judge wishes to address, the parties request that the prehearing conference scheduled for Thursday, September 5, 3029 be cancelled.




