



#### STATUS REPORT

COMES NOW the staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Status Report. In support thereof, Staff shows the following:

#### I. BACKGROUND

On September 12, 2018, Bluebonnet Hills Water Supply Corporation (Bluebonnet) and the City of Cresson (Cresson) (collectively, Applicants), filed an application for sale, transfer, or merger of facilities and certificate rights in Parker and Johnson Counties, Texas. Specifically, Cresson seeks approval to acquire facilities and to transfer water service area from Bluebonnet under water Certificate of Convenience and Necessity (CCN) No. 12290. The requested area includes approximately 436 acres and 164 connections.

On September 5, 2019, the State Office of Administrative Hearings (SOAH) administrative law judge (ALJ) issued SOAH Order Number 2, ordering Staff to file either a recommendation on the application or a status report on Staff's review of the application by October 4, 2019. This pleading is therefore timely filed.

#### II. STATUS REPORT

Staff is in the process of reviewing the application and respectfully requests an additional thirty (30) days to complete its review.
