SUPPLEMENT TO AGREED PROPOSED NOTICE OF APPROVAL

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, files this Supplement to Agreed Proposed Notice of Approval and would show the following:

On September 12, 2018, Bluebonnet Hills Water Supply Corporation (Bluebonnet) and the City of Cresson (the City) (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate rights in Parker and Johnson counties, Texas. Specifically, the City seeks approval to acquire facilities and to transfer water service area from Bluebonnet under water Certificate of Convenience and Necessity (CCN) No. 12290. The requested area includes approximately 436 acres and 164 connections. The Applicants filed supplemental information on September 27, 2018 and December 7, 2018. Order No. 11, issued June 23, 2020, established June 30, 2020, as the deadline for Staff and the Applicants (collectively, the Parties) to file a Supplemental Motion to Admit Evidence and Agreed Proposed Notice of Approval. Staff timely filed the Supplemental Motion to Admit Evidence and Agreed Proposed Notice of Approval on behalf of the Parties but inadvertently omitted the map and certificate as attachments. This pleading includes the map and certificate.

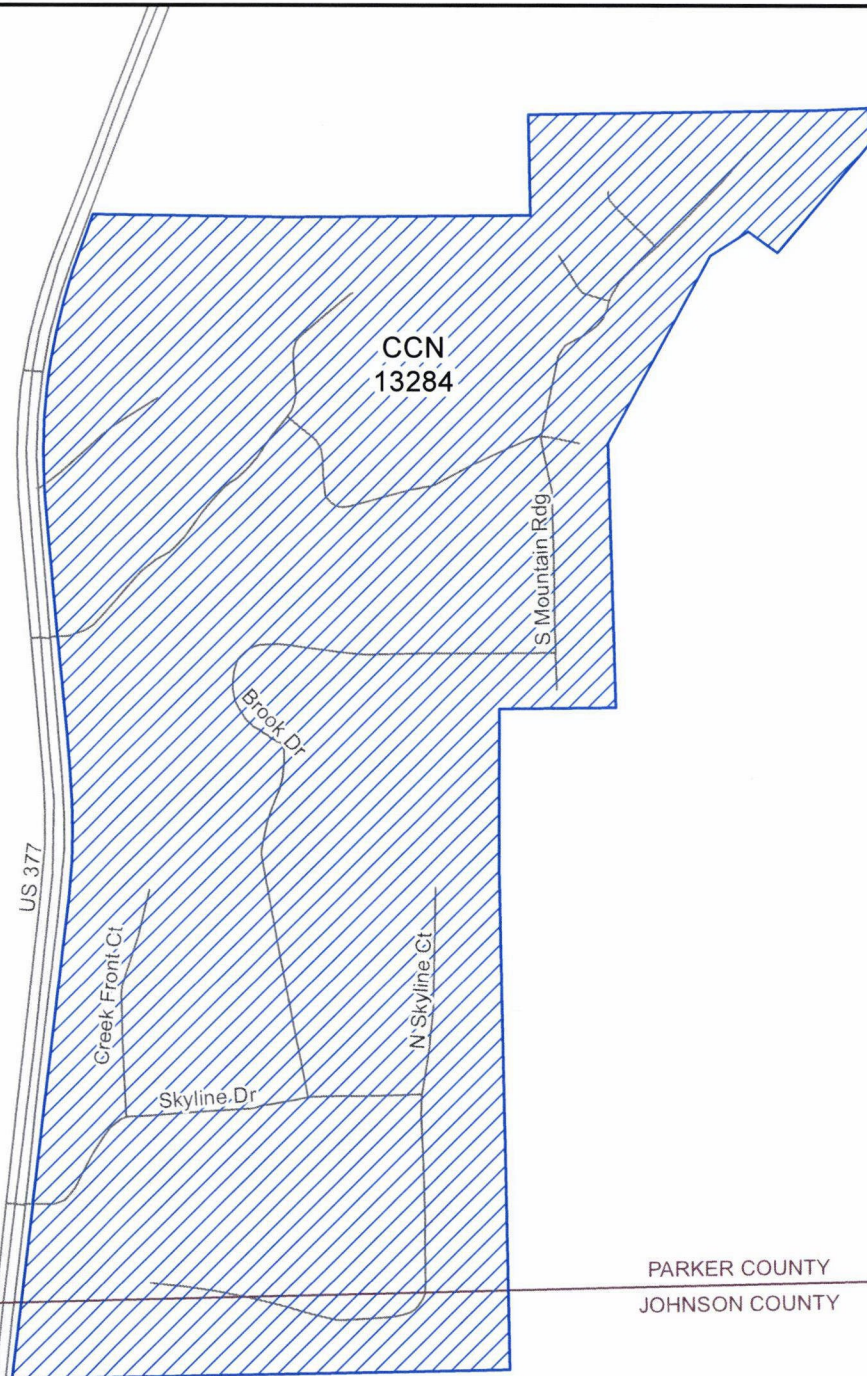
