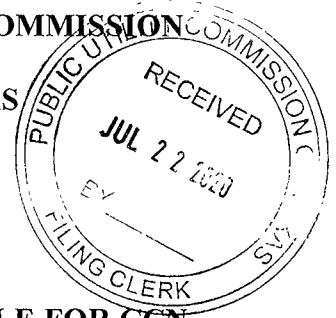

**AGREED SUPPLEMENTAL MOTION TO ADMIT RATE SCHEDULE FOR CCN
NUMBER 13284**

COMES NOW the City of Cresson (City) and Bluebonnet Hills Water Supply Corporation (Bluebonnet) (collectively, Applicants) with the agreement of the Staff (Staff) of the Public Utility Commission of Texas (Commission) (collectively, the Parties) and files this Supplemental Motion to Admit Rate Schedule for Certificate of Convenience and Necessity (CCN) No. 13284 and would show the following:

On September 12, 2018, Applicants filed an application for sale, transfer, or merger of facilities and certificate rights in Parker and Johnson counties, Texas. Specifically, the City seeks approval to acquire facilities and to transfer water service area from Bluebonnet under water CCN No. 12290. The requested area includes approximately 436 acres and 164 connections. The Applicants filed supplemental information on September 27, 2018 and December 7, 2018. Order No. 13, issued July 1, 2020, established July 22, 2020, as the deadline for the Parties to file an agreed-upon tariff and move for its admission in evidence or provide briefing explaining why no tariff is required.

Attached to this pleading is the City's rate schedule for customers in CCN No. 13284. The Parties hereby request its admission into evidence. The rate schedule includes the same rates as the rates charged to customers under CCN No. 11472¹ in order to provide uniformity across the City. Although the proposed rate formula is different than Bluebonnet's current rate formula, the net effect of the cost to the typical customer will be the same as shown in the City's application for sale, transfer, or merger of facilities and certificate rights filed on September 12, 2018.
