COMMISSION STAFF'S MOTION FOR ORDER NUNC PRO TUNC UNDER TEXAS RULE OF CIVIL PROCEDURE 316

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission) and requests that the Commission enter an Order *Nunc Pro Tunc* pursuant to Texas Rule of Civil Procedure 316 to correct a clerical error in the map and certificate attached to the Order issued in this docket.

I. BACKGROUND

On September 10, 2020, the Commission approved the sale and transfer of all of Bluebonnet Hills Water Supply Corporation's (Bluebonnet) facilities and service area under water Certificate of Convenience and Necessity (CCN) number 12290 to the City of Cresson (City), the cancellation of water CCN number 12290, and the amendment of the City's CCN number 11472. Attached to the Order was a certificate for CCN No. 11472, which referred to service areas in Johnson and Parker Counties, but not Hood County, and a map that referenced Cresson Water Works rather than the City of Cresson.

II. MOTION FOR ORDER NUNC PRO TUNC

Staff requests an Order *Nunc Pro Tunc* to correct clerical errors in the counties listed in the certificate and the CCN holder named in the title of the map. The certificate omits Hood County. Although the transaction approved in this docket only affected service area under CCN No. 11472 within Parker and Johnson Counties,¹ the certificate must include Hood County to reflect all of the counties in which service area under CCN No. 11472 is located. The title of the



¹ Because the service area affected by the application is located in Parker and Johnson Counties only, Staff is not requesting corrections to conclusion of law 10 or ordering paragraph 5 to include Hood County.

map indicates that Cresson Water Works holds CCN No. 11472. The title should be revised to reflect that the City of Cresson holds CCN No. 11472. Attached to this pleading are a certificate

and map that include the requested corrections.

The Commission can correct clerical errors in an order at any time pursuant to Texas

Rule of Civil Procedure 316. Because the requested changes correct clerical errors, and the errors

are not the result of judicial reasoning or determination, it is appropriate for the Commission to

correct the error through the issuance of an Order Nunc Pro Tunc.²

III. **CONCLUSION**

Staff respectfully requests the entry of an Order Nunc Pro Tunc correcting the clerical

errors in the certificate and map issued on September 10, 2020 as set forth above.




