COMMISSION STAFF'S REQUEST FOR A PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request for a Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On September 12, 2018, Bluebonnet Hills Water Supply Corporation (Bluebonnet) and the City of Cresson (Cresson) (collectively, Applicants), filed an application for sale, transfer, or merger of facilities and certificate rights in Parker County, Texas. Specifically, Cresson seeks approval to acquire facilities and to transfer water service area from Bluebonnet under water Certificate of Convenience and Necessity (CCN) No. 12290. The requested area includes approximately 436 acres and 164 connections.

On September 14, 2018, Order No. 1 was issued establishing a deadline of October 12, 2018, for Staff to file a recommendation on the administrative completeness of the application and notice and propose a procedural schedule for further processing of the application. Staff timely filed a recommendation on October 11, 2018, recommending that the application be found administratively incomplete and proposing a schedule for continued processing of this docket.

II. REQUEST FOR A PROCEDURAL SCHEDULE

Staff's October 11, 2018 filing recommending that the application be found administratively incomplete proposed deadlines for the continued processing of this docket. An order adopting a procedural schedule for this docket has yet to be issued.

Staff recommends that a schedule be adopted that gives the Applicants roughly one month to cure the deficiencies noted in their application, and that Staff be given roughly one month after that to file a supplemental recommendation on sufficiency of the application.

III. CONCLUSION

For the reasons discussed above, Staff respectfully requests issuance of an order establishing a procedural schedule for the continued processing of this docket.
