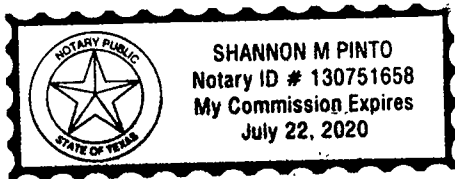

5. The Commission processed the application in accordance with the requirements of the TWC, the Administrative Procedure Act,<sup>1</sup> and Commission's rules.
6. Fremont has demonstrated that it has met the requirements of TWC § 13.1872 and 16 TAC § 24.49 for approval of the rate adjustments.
7. The requirements for informal disposition under 16 TAC § 22.35 have been met in this proceeding.
8. Under 16 TAC § 24.49(e), Fremont must provide notice after it receives a copy of this Order and 30 days before the effective date of the proposed change.

### III. Ordering Paragraphs

In accordance with these findings of fact and conclusions of law, the Commission issues the following orders:

1. The Commission adjusts Fremont's monthly water base rate to \$14.44 and the water gallonage rate to \$4.40 per 1,000 gallons.
2. The Commission approves the tariff attached to Commission Staff's supplemental recommendation effective 30 days after Fremont provides notice to its customers.
3. Fremont's new rates may go into effect 30 days after Fremont provides notice to customers.
4. Fremont must issue notice of the approved rate change to its customers at least 30 days before the effective date of the rate change.
5. Fremont must file proof of notice in this docket within ten days after notice is provided to customers.
6. Within ten days after Fremont files proof of notice, Commission Staff must file a clean copy of the tariff with Central Records to be marked *Approved* and kept in the Commission tariff book.
7. The Commission denies all other motions and any other requests for general or specific relief, if not expressly granted.
