### COMMISSION STAFF'S REQUEST FOR EXTENSION OF TIME

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Staff's Request for Extension of Time. In support thereof, Staff shows the following:

#### I. BACKGROUND

On October 1, 2018, Anderson Water Company, Inc. (Applicant) filed an application with the Commission for a water rate/tariff change with an effective date of November 28, 2018, under Certificate of Convenience and Necessity (CCN) No. 11675 in Grimes County.

On November 29, 2018, the Administrative Law Judge (ALJ) issued Order No. 3, giving Staff a deadline of February 21, 2019 to file a supplemental recommendation on the administrative completeness of the application and notice and to propose a procedural schedule, if appropriate. Therefore, this pleading is timely filed.

## II. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Because Staff is awaiting an additional filing by Applicant, Staff respectfully requests that Staff's deadline to file a recommendation regarding the sufficiency of the closing documents filed by Applicant to March 8, 2019. Staff has contacted the representative for Applicant and is authorized to represent that Applicant agrees to the extension.

#### III. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to file a supplemental recommendation on the sufficiency of the application to March 8, 2019.
