COMMISSION STAFF'S REQUEST FOR EXTENSION OF TIME

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Staff's Request for Extension of Time. In support thereof, Staff shows the following:

I. BACKGROUND

On October 1, 2018, Anderson Water Company, Inc. (Applicant) filed an application with the Commission for a water rate/tariff change with an effective date of November 28, 2018, under Certificate of Convenience and Necessity (CCN) No. 11675 in Grimes County.

On March 6, 2019, Applicant filed a corrected proposed notice with an effective date of April 26, 2019 and an Annual Revenue Increase of \$96,086 (53%).

On March 13, 2019, the Administrative Law Judge (ALJ) issued Order No. 5, finding the application and proposed notice sufficient and requiring Applicant to issue notice with the new effective date at least 35 days before the effective date of the proposed rate change. Applicant issued notice on March 15, 2019, which is greater than 35 days prior to the effective date. Applicant filed its proof of notice on April 17, 2019.

Furthermore, Order No. 5 required Staff to file a recommendation on Applicant's proof of notice and propose a procedural schedule 10 days after proof of notice is filed. This pleading is therefore timely filed.

II. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is awaiting an amended proof of notice from Applicant, who communicated to Staff that the notice documentation filed on April 17, 2019 includes an incorrect copy of the notice Applicant issued. The proof of notice filed on April 17, 2019 reflects an Annual Revenue Increase of \$86,976.16 (50%) instead of an Annual

Revenue Increase of \$96,086 (53%). Applicant will file a proof of notice that correctly reflects the Annual Revenue Increase of \$96,086 (53%).

Therefore, Staff respectfully requests that Staff's deadline to file a recommendation regarding the sufficiency of the notice documentation filed by Applicant to May 3, 2019. Staff has contacted the representative for Applicant and is authorized to represent that Applicant agrees to the extension.

III. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to file a recommendation on notice to May 3, 2019.


