Staff 2-1 Please provide the yearly salary by employee name for each employee of Anderson Water Company

Response: Please see attached flash drive containing confidential information requested.

Staff 2-2 Please provide a detailed description of services rendered by each employee for Anderson Water Company and for Anderson Plumbing Company.

Response: During the test year here are the employees listed and their services rendered for each company.

Rickey Wehmeyer- owner/operator oversees all operations of the company and jobs being completed for Anderson Water Company. Owner of Anderson Plumbing Company oversees all purchases made and inventory for parts.

Rick Bernard- Store Manager for Anderson Water Company, oversees all water accounts, takes payments, phone calls, helping with any customers needs on the water systems and delegate work being completed in the field to other employees. Completes billing, invoices, and payroll. Anderson Plumbing Company helps complete sales for any customers coming in to purchase store items.

Salvador Cerventes- Head Technician on water works for maintaining well sites, labor and repairs on all systems owned and operated by Anderson Water Company.

Ryan Sechelski- Technician on water works for maintaining well sites, labor and repairs on all water systems owned by Anderson Water Company.

Shawn Klawinsky- for Anderson Water Company took customers payments and handled phone calls. Anderson Plumbing Supply helped customers with store purchases and checking them out for sales.

Staff 2-3 Does Anderson Plumbing Company provide any plumbing services in addition to sales of plumbing supplies.

Response: No

Staff 2-4 Please provide the names of any employees or contract labor persons who are paid by Anderson Water Company and are licensed plumbers.

Response: We do not have any licensed plumbers who work at Anderson Water Company. We refer any customers to another company if they need extensive plumbing services. We work on primarily on our own water systems allowed by and licensed under Rickey Wehmeyer the operator/owner of Anderson Water Company.

Staff 2-5 Please provide the last 24 months of wireless phone bills for Anderson Water Company

Response: Please find attached on flash drive the wireless phone bills which we were only able to get back up to 16 months on past billing. All phone lines and charges are the same or very similar to our test year on usage, payments, and employees who had them in service at that time.

Staff 2-6 Please provide transaction details for individual sales and services performed by Anderson Water Plumbing Company for the test year.

Response: We already provided a profit and loss sheet prior for sales and services by Anderson Water Plumbing. Please see attached again for reference on flash drive.

Staff 2-7 Please provide any records available supporting the amount spent by each employee or contract labor personnel on Anderson Water Company and Anderson Plumbing Company.

Response: All employees are scheduled to be working on scheduled salary or pay scale from 8:00am-5:00pm Monday through Friday for Anderson Water Company. Anderson Plumbing Supply is also serviced from the same location and operations during that time frame. There are no specific time slots to provide or record saying one is more than another. Anderson Water Company experiences slow traffic of customers and calls coming in daily so sales from Anderson Plumbing Supply do not render time from the other. Sales/services for Anderson Plumbing Supply are handled within the time employees are there already operating daily for Anderson Water Company.

Staff 2-8 Please provide the mileage log for vehicles used for Anderson Water Company.

Response: Mileage logs are not used for Anderson Water Company.

Staff 2-9 Please provide the mileage log for vehicles used for Anderson Plumbing Supply.

Response: Mileage logs are not used for Anderson Plumbing Supply.

Staff 2-10 If mileage logs are not available, provide the amount of time the vehicles are used by Anderson Water Company, Anderson Plumbing Company, and personal use.

Response: The vehicles listed for the plants in service are only used for Anderson Water Company on daily operations of Monday-Friday 8:00 am-5:00 pm. Each weekend a vehicle is used to make daily rounds of each test site for monitoring levels and take about an hour to complete every Saturday and Sunday from about 9:00am-10:00am. Vehicles are also used on occasional emergency repairs to be made after hours and weekends that depend on each plant site.

Products for sales of Anderson Plumbing Supply are shipped directly to the store so vehicles are not used for that purpose of sales. We do not deliver any products to customers and are strictly in store purchases only.

Staff 2-11 Please state if any of the assets listed in the application are used for Anderson Plumbing Company.

Response: No assets other than the building use are used for Anderson Plumbing Company.

Staff 2-12 Please provide details, such as type and function, on each of the vehicles listed in the utility plant in service.

Response: 2015 Ford 150 is used for daily use of monitoring each test site, reading meters, & repairs
2015 Ford 350 is used for daily use of monitoring each test site and repairs
2006 Ford Ranger is used for reading meters monthly

Response: Our only main heavy equipment use is from our mini excavator listed and is used daily to dig lines and install new meters if needed.
