MOTION PROVIDING ALTERNATIVE DATES TO RESCHEDULE THE PRE-HEARING CONFERENCE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Motion Providing Alternative Dates to Reschedule the Pre-Hearing Conference. In support thereof, Staff would show the following.

I. BACKGROUND

On October 1, 2018, Anderson Water Company, Inc. (Anderson) filed an application with the Commission for a water rate/tariff change with an effective date of November 28, 2018, under Certificate of Convenience and Necessity (CCN) No. 11675 in Grimes County.

On January 13, 2020, the State Office of Administrative Hearings Administrative Law Judge (SOAH ALJ) issued SOAH Order No. 3 requiring Staff and Anderson to notify the SOAH ALJ as soon as possible so that the pre-hearing conference may be rescheduled if Anderson has not provided notice of the pre-hearing conference to customers, along with instructions on how to intervene. Staff contacted Anderson to clarify whether or not such notice had been sent, and Anderson informed Staff that such notice had not been sent. Staff files this motion to provide alternative dates for the pre-hearing conference to be rescheduled after Anderson provided notice as required by SOAH Order No. 1.

II. REQUEST TO RESCHEDULE PRE-HEARING CONFERENCE

Staff appreciates the SOAH ALJ's latitude in scheduling matters and would provide the following available dates for rescheduling the pre-hearing conference in this matter in order of preference:

1. Tuesday, March 3, 2020;
2. Thursday, March 5, 2020; or
3. Monday, March 9, 2020.
